**Opening Remarks**

Goldsmith, 33°, Sovereign Grand Inspector General for Florida, and the Grand Prior of the Supreme Council who passed away on January 22, 2010. Illustrious Goldsmith had a long and distinguished career in Freemasonry. In addition, to his work in the Scottish Rite, Illustrious Goldsmith served as Most Worshipful Grand Master of the Grand Lodge of Florida in 1983. He was an honorary member of the Melbourne York Rite Bodies and a member of the Cocoa York Rite Bodies.

It goes without saying that words cannot alleviate the loss of each of our departed Companions for each has created a void within our fraternity as well as someone’s heart. Only time will soften the blow.

### **State of the Craft**

Though out my travels this past Capitular year, I have found that the Thirty–eight Chapters are a varied group. Some have shown great proficiency in the work while others struggle to have enough members to open. This comes as no surprise and to assist the Craft I adopted as my Theme “Capitular Excellence through Focus”. My program has offered the local Chapters specific membership goals, personal activities, and methods of recognition to foster local chapter development. To this end the 2009-2010 Grand Chapter program has provided a link with the past yet allowed enough flexibility for the Chapters to govern their futures.

Membership and membership retention continue to be a large consideration for the future growth and survival of Capitular Masonry. It has often been said that we would show positive growth if it were not for our suspensions for NPD. With the “Short of Time” classes previously endorsed by The Most Worshipful Grand Lodge of Florida many of the Symbolic Lodges have produced a large number of raisings and some of the local Chapters have been able to capitalize on this. We must however, also concentrate on the caliber as well as on the quantity of our candidates. Overall I am encouraged with the reports of Exaltations performed this past Capitular year and feel that with committed teamwork we can continue to grow the local Chapters. Furthermore, I am pleased to report that for the state we exceeded the ten per cent goal increase. 2009 Exaltations were thirty-three per cent higher than the 2008 provided base number. Special recognition goes to the following Chapters for being the top four chapters in exaltations:

District meetings took a different format this past Capitular year. These were held on specific meeting nights and in conjunction primarily with The Grand Commandery. While there has been much discussion in recent years regarding the advantages versus the disadvantages of Area / District meetings and week - end versus week – night meetings, the philosophy employed this year was to provide a venue which would allow greater local participation. I am pleased with the well-run meetings this past year and thank all the District Deputy Grand High Priests working with their counterparts and local leadership for allowing these events to be very successful.

Communications have finally entered the twenty-first century through the first anniversary of the revised Grand York Rite web site format. Many thanks are offered to Sir Knight Ronald Blaisdell, P.I.G.M., Michigan, for his many, many hours of dedication to this project. Many articles, photos and announcements have been provided to keep the site updated and fresh. I thank each contributor for his dedication as well for without meaningful input, the site would have limited usefulness.

Schools of instruction continue to be a challenge for many of the Districts. I am most concerned that many of our constituent Chapters are still using palm cards and open rituals during the opening and closing at the stated Convocations. This brings great disrespect on our past heritage. Most of the ritual parts in the opening and closing are small. The importance of Schools of Instruction cannot be stressed enough. We all need it! This past year a team approach was utilized. The District Deputy Grand High Priest acting in conjunction with the District Instructor coordinated the administrative and the instructional aspects for the schools. While most Districts set up Schools of Instruction, less than half of the Districts produced reports. Of notable interest, Districts 2, 3, 4 and 8 are to be commended for their efforts. Excellent Companion John L. Horne, Jr., District 2 Instructor is to be highly applauded for his efforts as he received the first "White Card" proficiency status and his example needs to be used to encourage other Companions to do likewise.

In the end, Companions, our destiny lies with the local leadership of our Chapters. We must be progressive. We term the High Priest as "Excellent"; however, to be so he must have goals and strive to meet those goals. He must be willing to provide programs and activities that encourage the membership to participate. Activities that include a prepared meal, Masonic education, table chapters and family social activities all produce greater membership participation. Only through these methods and time honored traditions as well as innovative measures can we truly achieve "**Capitular Excellence through Focus**".

## GRAND TREASURER'S PRELIMINARY REPORT YEAR 2009-2010

This year has seen a very slow recovery from the recession that began at the end of 2008. While the overall balance in the investment accounts have not returned to their pre-recession balances, recovery gains have been recorded. One thing that has hampered the recovery has been the Federal Reserve's low and no interest rates. It has made the yield on money market funds and CD's extremely low and is barely above holding money in cash accounts as a reasonable alternative for investment. Too, the bond market has not offered a reasonable investment due to the ratings being very low and somewhat risky. So, the Investment Committees have taken a slow and cautious approach to the re-investment of cash accounts waiting for more secure and less risky instruments to become available.

A continuing problem exists in many of the constituent body's financial record keeping practices. Since the 9-11 tragedy, banking regulations have been greatly tightened. Gone are the days when anyone can walk into a bank and open an account for whatever reason. To open an account now, one must first have a Federal Identification Number, SSN or FEIN. And, if a non-profit organization, which is the category our constituent bodies generally fall into, desires to open an account, there must be incorporating papers as well. It would seem that a number of our constituent bodies are operating as the "York Rite of ..." If they have a FEIN for that entity and incorporation papers, that's okay. But, if not, sooner or later the bank will probably want to see those documents or require that they be obtained. Companions and Sir Knights, we are organized as Chapters, Councils and a Commandery under the general umbrella of the "Grand" bodies at the state level, and not the "York Rite of ..."

So, every constituent Chapter, Council and Commandery should have a separate FEIN and be properly incorporated and reporting as such to the Department of State of Florida. They should have separate checking accounts as well. And, by regulations, a copy of the non-profit corporate tax receipt should be on file with the Grand Secretary/Recorder's office after it has been paid each year. Another very critical report is the annual filing of the Form 990 with the IRS. A copy, or verification of filing, should also be on file with the Grand Secretary/Recorder's office. Every constituent Chapter, Council and Commandery with gross receipts of less than \$25,000.00 per year should have filed an e-Form 990 by December 31, 2009. Failure to do so for three succeeding years could result in a loss of non-profit status and we certainly don't want that to happen. Beginning with this year's tax return, everyone that had made the initial e-Form 990 filings can go to <http://epostcard.form990.org>, enter their ID and password and file an e-postcard. The process takes only minutes to complete.

Another critical area that has been overlooked by many of our constituent Chapters, Councils, and Commanderies has been the requirement that the Secretary/Recorder along with the Treasurer be bonded. This is required by our regulations. For most of the Chapter, Councils and Commanderies a fidelity bond shouldn't cost more than \$150.00. But, there are several things that they must be aware when applying for a bond. Most bonding companies will require answers to the internal record keeping procedures. At a minimum the following should be followed:

1. Have an annual audit completed by other than those having access to the receipting and depositing of monies and the check writing.
2. Have a dual signature requirement for each check.
3. Have a separate check account for each of the constituent bodies (and, FEIN).
4. Letterhead stationary designating who is the Secretary and Treasurer, signed by the presiding officer.

Check with local insurance agencies to see if they write fidelity bonds and check more than one to get the best rates.

Along with a fidelity bond, each Chapter, Council and Commandery should also inquire into a General Liability policy with a minimum of \$100,000 coverage. And, if the building is owned, property insurance is a must.

## GRAND HISTORIAN'S LECTURE

Grand Historians Lecture for 2009/2010  
"1812 and the Hero"

*For the want of a nail, the shoe was lost,  
For the want of a shoe the horse was lost,  
For the want of a horse the general was lost,  
For the want of a general the battle was lost.*

At one time in the history of the United States, General Andrew Jackson of Tennessee was honored above all other living men. There was also a time when the date of January 08<sup>th</sup> was of great importance. For about fifty years it was celebrated with the same zeal as the 4<sup>th</sup> of July. But, for some reason by the end of the American Civil War in 1865, the magnitude of the date had diminished. The event that took place in 1815 during the War of 1812 left one man with the perpetual title of "the Hero of New Orleans." The victory was directly responsible for placing a once-poor, wretchedly educated orphan boy into the White House. Jackson had none of the qualifications of his presidential predecessors. It was said that the only thing he excelled at was killing. He killed Indians, Spanish, and of course the British. As one woman in Salisbury, North Carolina, exclaimed on hearing of Jackson's nomination, "What! Jackson up for the President? Jackson? Andrew Jackson? The Jackson that used to live in Salisbury? Well if Andrew Jackson can be President, anybody can!"

The Battle of New Orleans possessed all the ingredients of a grand Hollywood epic film. It had a home-grown, popular military hero nicknamed "Old Hickory;" a ragtag militia of regular and citizen soldiers that included frontiersmen, Creoles, Indian sharpshooters, free blacks, the people of New Orleans, and the notorious pirate Jean Lafitte and his renegade banditti. Arrayed against them were the mighty British Navy and the most elite regiments of the Duke of Wellington's victorious army, fresh from their defeat of Napoleon at Waterloo.

It should have been a rout, this unequal battle between some 8,000 British regulars supremely confident of crushing all opposition in their path and Andrew Jackson's bizarre group of defenders, whose numbers were barely half that of their enemy. Fought in the most unlikely of places, the Battle of New Orleans actually took place on the Plains of Chalmette, approximately ten miles south of New Orleans on the east bank of the Mississippi River. The British expected to punch their way straight north to New Orleans, collect the "Beauty and Booty" that awaited them, and

then head up the Mississippi Valley to join with British troops coming from Canada, effectively slicing the United States in two.

The attacking force consisted of disciplined regulars of the British army including the Royal Fusiliers, Highlanders, Light Infantry, Light Dragoons, a West Indian regiment, and sailors from the fleet anchored in the Gulf of Mexico. It should be noted that when the War of 1812 began, the U.S. Navy consisted of seventeen oceangoing ships while the British fleet numbered seven hundred.

The U.S. acquired New Orleans as part of the Louisiana Purchase from France in 1803.

The population was largely composed of Creoles and Blacks. When Andrew Jackson learned of the British intention to seize New Orleans, he responded by thundering, "I will smash them, so help me God!" The Louisiana ladies did not share in Jackson's confidence and decided to take no chances. They armed themselves with daggers instead of scissors. They had recently seen Jackson's vaunted "Dirty Shirt" Tennesseans under General John Coffee's command, and they had serious doubts about the ability of these men to stand up to British regulars. There was absolutely nothing military-looking about them. They wore woolen hunting shirts of "dark or dingy color" and "copperas-dyed pantaloons," both made at home by wives, mothers, and sisters; with slouching wool hats made of raccoon and fox skins and belts of untanned deer skin, into which they stuck hunting knives and tomahawks. Their long, unkempt hair and bewhiskered faces might scare a Creole lady but hardly the troops of His Majesty's army. But what the ladies did not know was that most of these men could bring down a squirrel from the highest tree with a single rifle shot. Their many years living in the Tennessee wilderness had made them expert marksmen, and their many months of military service, in fighting Indians under the command of Generals Coffee and Jackson, had converted them into disciplined soldiers.

On December 24, 1814, Jackson set up his army behind an old millrace called the Rodriguez Canal between the Macarty and Chalmette plantations. It was a ditch four feet deep and ten feet wide that ran

at a right angle from the east bank of the Mississippi into a thick and almost impenetrable cypress swamp. Jackson chose this position because it provided the narrowest front between the river and the

swamp, and made an excellent barrier to defend against an advancing enemy. Immediately work began on widening and deepening the canal, and building a rampart from the mud and debris dredged out of the bottom of the ditch. Over the next several days, the soldiers erected an earthen rampart, and installed twenty-four artillery pieces at regular intervals. The men competed to see which group could build the highest mound in front of their position. Jackson rode his horse among the troops as the work was being done, and assured them by saying, "Here we shall plant our stakes, and not abandon them until we drive these red-coat rascals into the river, or the swamp." Overall the Jackson line ran about three-quarters of a mile.

In the early morning of January 8th, British Lieutenant General Edward Pakenham ordered a two-pronged assault against Jackson's position: a small force on the west bank of the Mississippi and the main attack in three columns directly against the earthworks manned by the vast majority of the American troops.

Preparations for the attack had foundered early, as a canal being dug by Admiral Cochrane's sailors collapsed, and the dam made to divert the flow of the river into the canal failed leaving the sailors to drag the boats of Col. William Thornton's west bank assault force through deep mud, and left the force starting off just before daybreak, 12 hours late.

Lt-Col. Thomas Mullins, the British commander of the 44th Regiment of Foot, was a particularly incompetent officer. The Forty-fourth was ordered out in advance of the main column commanded by Major General Samuel Gibbs. They were instructed to carry fascines and ladders with them. The fascines were bundles of sugar cane to be thrown into the ditch in front of Jackson's line to fill it up. The sixteen ladders assigned for the operation were needed to scale the rampart. The fascines and ladders had to be in place in order for the advance to move forward smoothly once the attack began. The Forty-fourth Regiment moved rapidly but quietly. They were almost in position when they realized their blunder. They had forgotten the fascines and ladders! A quicktime to the rear was ordered to retrieve them. Then a frantic race to get back into position before the signal to attack. But it was too late. The battle had commenced.

The attack began under darkness and a heavy fog, but as the British neared the center of the Jackson line, the fog lifted exposing them to horrific artillery fire. Most of the senior officers were killed or wounded, including General Gibbs, killed leading the main attack column on the right, and Colonel Robert Rennie leading a detachment of light companies on the left by the river. Possibly, because of Thornton's delay in crossing the river and the withering fire that might hit

them from the artillery across the river, the 93rd Highlanders were ordered to leave General John Keane's assault column advancing along the river, and move across the open field to join the main force on the right of the field. Keane fell wounded as he crossed the field with the 93rd. Rennie's men managed to attack and overrun an American advance redoubt next to the river, but without reinforcements they could neither hold the position, nor successfully storm the main American line behind. Within minutes, the American 7th Infantry arrived, moved forward, and fired upon the British in the captured redoubt. Within half an hour, Rennie and most of his men were dead. In the main attack on the right, the British infantrymen either flung themselves to the ground, huddled in the canal, or were mowed down by a combination of musket fire and grapeshot from the Americans. A handful made it to the top of the parapet on the right, but were either killed or captured. The 95th Rifles had advanced in open skirmish order ahead of the main assault force, and were concealed in the ditch below the parapet, unable to advance further without support.

The two large main assaults on the American position were repulsed. Pakenham was fatally wounded by grapeshot fired from the earthworks. With most of the senior officers dead or wounded, the British soldiers, with no orders to advance further or retreat, stood out in the open and were shot apart with grapeshot from the Jackson artillery. After about 20 more minutes of bloodletting, Major General John Lambert assumed command and eventually ordered a withdrawal. Several Americans rushed onto the field to take captives. One Tennessean came upon a slightly wounded British officer and demanded his surrender. The officer looked at his dirty, unkempt, wild-eyed captor with contempt. Surrender to such a person? Never. He disregarded the call and kept walking toward his own lines. "Halt, Mr. Red Coat," the dirty shirt cried out, as he drew a bead on the officer. "One more step and I'll drill a hole through your leather." The officer froze in his tracks, turned around, and with a look of profound resignation said, "What a disgrace for a British officer to have to surrender to a chimney-sweep!"

The bodies of several of the slain British officers, including Generals Pakenham, Gibbs, and Colonel Rennie, were reportedly disemboweled and the cadavers encased in casks of rum to be shipped back to England for interment.

The Battle of New Orleans was one of the great turning points in American history. It was America's first great military victory and a defining moment for the nation. National pride hadn't been this high since Washington destroyed the British at Yorktown. In a single stroke, Old Hickory had established himself as one of America's greatest generals and the savior of the nation. One newspaper proclaimed: "Who would not be an American? Long live the Republic!" Companions, thank you for your attention.

## **GRAND COMMITTEE REPORTS**

### **AUDIT COMMITTEE REPORT**

The records of the Grand Treasurer, for the period June 1, 2008 to May 31, 2009, were examined at his home on November 9, 2009 by Most Excellent Companion Darryl A. D'Angina and myself. The other members of the Audit Committee were unable to travel to Panama City due to scheduling and work conflicts.

A thorough review of each Voucher and the related entries into the financial records of the Grand Chapter was done. All checks were accounted for in a review of the bank statements and compared to the vouchers. Deposits into the accounts of the Grand Chapter were verified to be correct. The Grand Treasurer's records were found to be a true and correct accounting of the Grand Chapter's funds.

During the course of the audit it was recommended that more detail be provided in the monthly reports submitted to the committee, this recommendation has subsequently been incorporated.

I examined the Records of the Office Account and the Grand Secretary on January 26, 2010 at the Grand York Rite Office. Again scheduling and work conflicts precluded the participation of the other members of the Committee. The warrants were reviewed and sample transactions were examined. The transactions examined were found to track correctly to the records maintained by the Grand Treasurer. Deposit records were found to match bank statements and records of the Treasurer.

It was found that payments for convention activities were deposited into the Office Account as the monies coming in were not payments to any one of the three Grand Bodies. This could be considered contrary to the specific wording of the Constitutions and either the Constitution or the practice changed so that they are not in conflict.

Subsequent to the audit of the Office Account, the Most Excellent Grand High Priest in conjunction with the Most Illustrious Grand Master and the Right Eminent Grand Commander issued Executive Orders directing the establishment of a Convention Checking Account and the transfer of all funds for the Convention to that account.

### **RECOMMENDATIONS:**

The majority of the Treasurer's records were contained on the computer not as printed reports, Monthly Balance Sheets and Profit & Loss Statements should be printed to facilitate the audit. Also, a year end print out of the General Ledger should be made.

A monthly backup of the computer files should be made and a copy sent to the Grand Secretary's Office to ensure that the records could be reconstructed in the event of a natural disaster. Likewise a copy of the same should be retained by the Grand Treasurer should there be a computer failure.

That the Grand Bodies purchase a laptop computer for the use of the Grand Treasurer to maintain our financial records. Currently, the Grand Treasurer is using his personal computer for this purpose.

(Note: It is also my recommendation that a thorough review of our business practices be made to ensure that we are in compliance with current practices and laws.)

On behalf of the Committee I wish to thank the Most Excellent Grand High Priest for the opportunity to serve him and the Grand Chapter. Submitted February 15, 2010.

### COMMITTEE ON WORK

M. E. James P. Rudman instituted a District Instructor program for the Grand Chapter of Florida in the 2008-2009 Capitular Year. It was reported at the Annual Convocation in 2010 that the start-up had been difficult, but that the next year would see improvement. That prophecy has come true with a flourish.

This year, all but one (1) of the ten District Instructors held multiple schools of instruction. Some held district-wide schools that encompassed about as wide a variety of topics as can be imagined. Some instructed at meetings of constituent Chapters. Some did both. Topics ranged from opening and closing to floor work to receiving distinguished guests to degree work to proper handling of properties and paraphernalia. ## **CUSTODIAN OF RITUALISTIC MATERIAL**

As custodian of Ritualistic Materials it is my responsibility to account for the Ritualistic Materials held by each Chapter. Sadly I must report, as my predecessor had last year, that very few are in possession of the required materials.

In our Ceremony of Installation, as the High Priest, King and Scribe receive their individual charges of duties of their office one of these import charges is to be presented with their own copy of Appendix “D” of the Constitution and Regulations on the Grand Chapter of Royal Arch Masons of Florida. They are instructed to study and inform their Companions of the information contained their-in. They are also presented with the “Book of Essentials” and a copy of the “Key Lecture”. It is obvious that this has not been the case in the vast majorities of the Chapters around the State for many years. Taking a poll within a 100 mile radius not one Chapter had or distributed these important documents nor had any remembrance of where they may be. After several years of the Committee reporting the same results and with the 100 mile test sample I have not gone to expanse of re-polling the Chapters again this year. If over 80 percent of the Chapters did not have these materials last year and the Grand Secretary had not reissued these materials these Chapters still would not have them. The odds that several of the Chapters that did have these materials last year would not have them returned and would now be misplaced appear to be high.

Therefore it is the recommendation of this Committee that the Grand Secretary be instructed to obtain a sufficient number of these important materials and have them distributed to each Chapter. It is further recommended that each Chapter be required to give an accounting of these materials as part of the year end reports. The chairman of this committee at this point could with the assistance of the Grand Secretary compile the needed reports.

If we truly want our ritualistic work to improve it is imperative that all constituent Chapters have the necessary material required to achieve this goal including the Appendix “D”, “The Book of Essentials” and the “Key Lecture”.

## FIVE YEAR PLAN

A meeting of the Grand Chapter Officers was called by R.E. Anthony Marotta, with the permission of M.E. D'Angina, on August 22, 2009, for the purpose of reviewing the 5 year plan. The meeting was held at Citrus Masonic Lodge in Inverness FL at 12 noon and was opened with prayer. The officers present were M.E. Darryl D'Angina, R.E. Anthony Marotta, R.E. Robert G. Kirkpatrick, Ex. Cal Bonnett, Ex. John Wermann, Ex. William Jacobs and Ex. Wayne Thigpen.

M.E. D'Angina started by reviewing his year of the 5 year plan, although it was still early in his year. Most Excellent expressed his thoughts of Increasing membership by ten percent and all Chapters exalting at least one and also new Companions be given a copy of "York Rite of Freemasonry." The importance of reporting was stressed and the need for recruiting events. Companions being able to Open and Close, a Chapter meeting from memory was emphasized. Each District should hold an Ancient Craft Table Chapter and the possibility of using a modified ritual to allow open Table Chapters. Discussion ensued on using part of the Mark Masters Degree as a tool to use in the Blue Lodge to help increase exaltations. Use of the Florida Grand York Rite website was also stressed. Questions were asked by several of the Companions and ideas exchanged for improvement, addition and/or removal of current plans.

It was suggested:

- that we continue to support of the Grand Lodge and its officers and promote "What can we do for you?"; among the local Blue Lodges.
- that we continue to review of the financial records and adapt appropriate legislation to support long term fiscal planning.
- that we promote Religious Affirmation.

The importance of communication with the other officers and the craft was discussed at length and deemed a necessity in our future conduct of business, especially the fraternal aspects.

The review then went to Right Excellent Companion Anthony Marotta. Much of the same covered with additional points being brought up. Guide lines for Blue Lodge Representatives, issuing Pins for newly installed Masters, supplying Chapters with the "York Rite of Freemasonry." Covered was a possible award competition for Opening and Closing the Chapters and/or Key Lectures. Right Excellent brought up promoting the Memorial Perpetual Membership program. Making sure the Grand Chapter Constitution was brought up to date by examining the past proceedings. In the realm of Public Relations, the use of Lady's Program and supporting the Grand Masters Charity should be considered in addition to our current programs. The idea of a state wide golf tournament and weekend rally was also discussed for Charity. There was discussion of the General Grand Chapter and continued support for the Royal Arch Research Assistance program. The continued use of the website and monthly education pieces being sent out to the Chapters was also discussed.

Right Excellent Bob Kirkpatrick covered his year of the Five Year Plan with most being reviewed previously. The idea of recognition for Top Line Signers at Grand Convocation rewards along with recognition of Eagle Scouts at District Meetings, support for flags in schools, and placing a York Rite plaque at the National Cemetery at Bushnell (an idea liked by all) was discussed for Public Relations. It was hoped that the idea of a York Rite plaque would be used in future years at the other National Cemeteries.

The other Companions added their support and made additional suggestions and comments. The meeting was well received and closed in peace and harmony at 2:30 p.m. with prayer.

## Grand Chapter Investment Committee Report

The Investment Committee met formally twice to discuss the account status and present state of the investments, followed up by numerous Emails and phone calls between Committee members, the Grand High Priest and the Grand Treasurer. This facilitated committee performance monitoring and along with the statements provided by the Grand Treasurer, formed the basis for recommendations and actions of the Committee.

This Capitular year was shadowed by a marked down turn in the market and was barely recovering in May 2009 from the March 3, 2009 all time market low since the Great Depression. Our Administrative Endowment and Perpetual Sacred accounts were moving positively off the bottom at the commencement of this committee's tenure and continued to rebound throughout the year. This positive return was clearly the result of market recovery and the expected performance of market return after its crash. The Administrative Endowment has gained 24% in assets this year, with an ending balance of \$188.8 K (as of April 30, 2010). The Perpetual Membership fund has equally rebounded 26% from the beginning of the year with its year end value at \$241 K.

The Sacred Account remains in an asset allocation with over 93% in risk-laden mutual funds, contrary to the Grand Chapter's Constitution and Regulations, i.e. Chapter 41 – risk mitigation guidelines of invested ratio of 40% fixed assets (bonds, etc) and 60% in equities (stocks, mutual funds, etc) in order to maintain moderate risk of the assets of this Grand Chapter. Fiduciary responsibility to uphold the Constitution and Regulations rests solely in the hands of the Grand High Priest, based on his Investment Advisory Committee's recommendation. The Committee's hands were tied by the fact that Raymond James could not produce adequate fixed asset investments yielding the required minimum of 5% yield criteria for accumulated cash in the Perpetual Membership Fund, which accumulated cash and retained a cash position of \$27.8 K beginning in July 2009 until a balance of \$35K was reached in February 2010, while in parallel the Council's funds were being invested with yields greater than 5% during the same time frame. The account remained in this cash position until steps were taken by the GHP to receive adequate attention to matter by Raymond James.

An unauthorized Grand Chapter 'reserve fund' surfaced in the Raymond James account valued at \$1K. The account was initiated and executed directly with Raymond James, under whose action was not clearly evident to Grand High Priest D'Angina, the Grand Treasurer, or this Committee. Upon its discovery, Grand High Priest D'Angina liquidated the account and returned the funds to the Perpetual Membership fund.

It is the recommendation of the Committee that its successors closely monitor market recovery and when appropriate, re-allocate the Grand Chapter's funds to a lower risk 40/60 asset allocation and closely monitor actions taken by any person or committee without the Grand Treasurer's knowledge. Additionally, it is the recommendation of the Committee that consideration of placing the account in the hands of another broker within Raymond James is strongly encouraged- i.e. e one that has the interests of the Grand Chapter in mind rather than holding large cash positions in the Perpetual Membership Fund.

The Committee would like to thank the Grand High Priest, M.E. Darryl D'Angina for allowing this Committee to serve at his will and pleasure during this fiscal Capitular year.

## JURISPRUDENCE COMMITTEE REPORT

To avoid the expense of calling an extra meeting somewhere in the state, copies of all legislation were mailed early in April to the committee members for their study and preparation for the meeting held April 14th with Most Excellent Darryl D'Angina in Lake Mary, Florida, to review his Grand High Priest's Report of his activities while in office, as well as all pending legislation. We find that the actions and decisions he made as Grand High Priest were well thought out and in keeping with the Constitution he swore to uphold and within the prerogatives of his office.

We examined five (5) Bylaw Amendments; one was disallowed because it was not in proper form but was approved at a subsequent resubmittal after being corrected. Most Excellent D'Angina approved four (4) Bylaw Amendments, all in proper form and all dealt with and sealed correctly. The Grand High Priest also received seven (7) Requests for Dispensation; six (6) were for routine reasons such as a Table Chapter and were approved; one (1) was for the formation of a new Chapter (Solomon) to be based in Leesburg, but was denied because it would have violated our Constitution. (This was later submitted as an Amendment to the Constitution.) This Committee deems the Grand High Priest to have acted correctly in all the above.

The Jurisprudence Committee also reviewed six (6) Amendments to the Constitution. Two (2) were judged to be not in proper form because they lacked a date for implementation. The remaining four (4) Amendments were in proper form and submitted properly.

Most Excellent D'Angina made six (6) Recommendations, all of which the Committee found to be worthy and germane to the business of this Grand Chapter, and should be adopted as an ongoing pursuit.

The Committee wishes that Most Excellent D'Angina's work schedule had permitted him time for more out-of-state visitations; nonetheless, he had a very busy Masonic year. At the meetings he was able to attend, he represented our Grand Chapter very well. He also made many official visits to our constituent Chapters and was asked to install the officers of several Chapters and Blue Lodges. He was active in many of the Appendant bodies as well.

Most Excellent Companion D'Angina is to be commended for the job he has done this year. This Committee very much appreciated his diligence in responding to the various items of business that came his way, and for his meticulous attention to every detail of his tenure. Each member of this Committee expresses his personal gratitude for the privilege of thus serving this Grand Chapter and Grand High Priest.

## Long Range Fiscal Planning Committee

This year three quarters of the long range fiscal planning committee have submitted legislation that we feel will improve the fiscal outlook of the Grand Chapter.

The first is just housekeeping and puts into the Constitution the Administrative Endowment fund and the manner in which it can be used by the Grand Chapter, we are already operating in this manner and with the voluntary moratorium have not need the guidelines for it's use. However, after the next two years that moratorium will be lifted and the guidelines need to be in place.

The second deals with the Budget Administrative Fund and although we are currently placing the current years per capita in this account for use by the Grand King for his budget, this legislation encompasses other sources of income, which would include fundraising, for the Grand King to complete his Budget during his year, thus improving his planning for his year as Grand High Priest.

Unfortunately the third piece of legislation deals with a per capita increase. The numbers tell the story. Our members are decreasing due to death, age and NPDs, but our costs keep increasing, in addition to this the Grand Chapter has absorbed the per capita increase from the General Grand Chapter over the past few years and has not passed the obligation down to the local Chapters. Any home owner can account for the increase in costs to maintain their home, this is not rocket science. However decreasing income, due to the afore mentioned reasons, has forced us to cut our Budget to the bare bones minimum. The effects are starting to be felt. Without the support of the Craft the programs that we are putting into place, in accordance with our five year plan, which will hopefully help solve some of these woes, will have to be dropped or rendered ineffective due to lack of funds.

We look for your support on these pieces of legislation

We would also like to suggest that future planning committees look at a reserve account within our perpetual membership account, to be able to be used in years when 5% is unobtainable. This would allow us to use this reserve fund rather than dip into principal.

We admonish them to continually review legislation and adjust it, as to better fit our needs.

We realize that this will change the way we do our accounting and trust that the Grand Treasurer will make adaptations to the current system to accommodate the changes made.

Finally we recommend highly to the Grand High Priest that the use of professionally qualified companions on our financial and investment committees be earnestly sought. The time has passed when lay persons can understand the complexities of today's financial markets and conditions.

Your Committee has determined that in addition to the added information we placed into Appendix "E" there were needed corrections in punctuation, and grammar. That coupled with the required strikethroughs, bolding, and underlining would have caused quite an untidy and somewhat messy appearance in the document. This would have caused undue distraction with possible confusion. We have updated the document. We are submitting a Resolution to repeal, set aside, and do away with the existing **Masonic Capitular Protocol** manual or handbook as adopted on May 15, 2007

that created and is **Appendix “E”** to our Constitution, **and**, at the same time, **ADOPT** the 2010 report and the Resolution of your Protocol Committee authorizing an updated and continuing **Appendix “E” Masonic Capitular Protocol** handbook or manual in our **Constitution Rules and Regulations**, with an **Effective Date of April 15, 2010**. This has been done in pursuit of neatness and clarity in its documents, adhering to proper protocol, and in order to conform to the existing rules for adoption of legislation before this Grand Chapter.

We are sending this revised Appendix “E” to the Grand Secretary with the accompanying Resolution To Amend the Constitution Rules and Regulations. A copy of this report of your Protocol Committee will accompany the said documents.

The committee thanks you for allowing us the opportunity to serve you and this Most Excellent Grand Chapter of Royal Arch Masons of Florida. We pray that the requested amendment will be adopted at the Grand Convocation on April 15, 2010 in Lake Mary.

I am thankful for the generosity of our Royal Arch Masons, especially while we endure such a strange economic interlude. I also thank the Grand High Priest for the privilege and honor of serving on such an important committee.

### Souvenir Program

Thank you for the honor and privilege of serving the Grand York Rite as Chairman for the 2010 Grand York Rite Souvenir Program. Other members on this committee included: John Allen (sales-south), David A. Aponte (layout), John Babski (repro), Ron Blaisdell (electronic distribution) chic Cicero (cover layout), William Jacobs (sales-panhandle), Dayle Schrock (sales- East Central), and Edwin Moore (advisory). Everyone's contributions made this year's sales possible.

Every effort was made to ensure accuracy and professionalism in the Souvenir Program; however, to err is human and we hope that our Companions and Sir Knights can exercise that Divine attribute of forgiveness of any transgressions as they were clearly unintentional.

Our campaign efforts were respectable because we maintained several successful key elements from past years, including several experienced sales coordinators and layout staff, and using the communications tools available to us today, particularly e-mails and scanners.

Revenue was down from the past couple of years. We suspect this due to being in the grips of an economic recession that has been compared in many respects to the Great Depression, and in using e-mail transmittals in an attempt to alleviate postage and reproduction costs associated with the flyers. The latter was an experiment and was moderately successful once we got the word out again to the Secretaries and Recorder; not every Secretary and Recorder has e-mail access yet, and some e-mail addresses in the Directory just bounced.

While the audited results are not yet complete to date, our records indicate that \$7,545.00 was generated for the campaign. Expenses are estimated to be about \$1,500.00, leaving net earnings to the Convention of \$6,045.00.

## RESOLUTIONS

### RESOLUTION TO AMEND THE CONSTITUTION AND REGULATIONS OF THE GRAND CHAPTER OF ROYAL ARCH MASONS OF FLORIDA

Chapter Thirty of the Regulations of the Grand chapter of Royal Arch Masons of Florida now reads:

#### CHAPTER THIRTY -- CHAPTER RETURNS AND REPORTS TO GRAND CHAPTER

##### **30.01 Annual Returns.**

- A. The Per Capita Tax levied against constituent Chapters and paid with their Returns not later than 15 February each year shall be eight Dollars (\$8.00) [May 2004, Effective Dec. 28, 2004]
- B. A Companion who has been a Royal Arch Mason in good standing for a period of fifty or more years, and who has not been disciplined, suspended or expelled for an offence involving moral turpitude, and if twenty-five years of such service have been in a Florida Chapter or Chapters, shall be exempt from all Grand Chapter annual per capita tax, dues, and assessments.
- C. A Companion who has been a Royal Arch Mason in good standing for a period of forty or more years, and who has not been disciplined, suspended or expelled for an offence involving moral turpitude, and if twenty-five years of such service have been in a Florida Chapter or Chapters, shall be exempt from fifty per cent (50%) all Grand Chapter annual per capita tax, dues, and assessments. [May 2004, Effective Dec. 28, 2004]

Be it hereby resolved that Chapter Thirty – Chapter Returns and Reports to Grand Chapter be amended to read as follows:

#### CHAPTER THIRTY – CHAPTER RETURNS AND REPORTS TO GRAND CHAPTER

##### **30.01 Annual Returns**

- a. The Per Capita Tax levied against constituent Chapters and paid with their returns not later than 15 February each year shall be **ten Dollars (\$10.00). Effective Dec 28, 2010.**

- b. A Companion who has been a Royal Arch Mason in good standing for a period of fifty or more years and who has not been disciplined, suspended nor expelled for an offense involving moral turpitude, and if twenty-five of such service have been in a Florida Chapter or Chapters, shall be exempt from all Grand Chapter annual per capita tax, dues and assessments.
- c. A Companion who has been a Royal Arch Mason in good standing for a period of forty or more years and who has not been disciplined, suspended nor expelled for an offense involving moral turpitude, and if twenty-five of such service have been in a Florida Chapter or Chapters, shall be exempt from fifty per cent (50%) Grand Chapter annual per capita tax, dues and assessments.

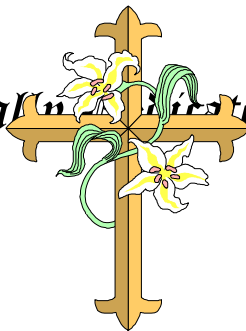
