JACKSONVILLE CHAPTER, No. 12, Jacksonville, Jan'v 3rd, 1856.

Dear Sir and Companion:

Your favor, without date, in reply to a communication addressed by our former Secretary, Companion Cole, under date Sept. 8th '55, was submitted to the members of our Chapter, at its last meeting, 28th December.

I am directed to say, that this Chapter claims as a *right* the amount received by yours from Companion Sadler, and that it will not receive it as a *gratuity*.

I am instructed further to say, that while this Chapter freely admits that "Florida R. A. Chapter, No. 1, is not to be informed of Masonic duty," (I quote your own words,) this Chapter claims also the same right, viz: that of acting without the dictation of yours.

The Committee on Propositions and Grievances, to whom was referred a letter from Jacksonville Chapter, No. 12, on the subject of the fees due for the exaltation of Companion Sadler, beg leave to report the following resolution as the sense of this Committee:

Resolved, That no fees are due from Florida Royal Arch Chapter, No. 1, to Jacksonville Chapter, No. 12, arising from the exaltation of Companion Sadler; because Companion Sadler was unable to obtain the degrees in his own Chapter, the same were conferred in the Florida Royal Arch Chapter, No. 1, in compliance with the request of Companions Barrett and Douglas of Jacksonville Chapter, No. 12, and under dispensation of the Grand High Priest,

in order to give to the Jacksonville Chapter a sufficient number of members to confer the degrees.

[The G. H. Priest was not present after the first evening, being detained at home by the sickness of his family; consequently did not deliver the usual address.]

The Committee on Dispensations and By-Laws made the following report:

The Committee on Dispensations and By-Laws report in favor of the proposed amendments to the by-laws of Columbia Chapter, No. 9: Amendments to By-Laws of Columbia Royal Arch Chapter, No. 9, Alligator, Florida adopted June 4th, 1855.

- 1st. That the word "one" be substituted for "five" in the 4th line of the first section, 4th article of the by-laws under the head fees.
- 2nd. That the words "until the next stated meeting," in the 4th section of the 4th article, be stricken out, and the words "until the Chapter shall be satisfied that the candidate has made suitable proficiency in the preceding degrees," be inserted in lieu thereof.

The above amendments were proposed at the regular meeting of the Chapter on 7^{th} of May, 1855, and on the

next stated meeting of the Chapter, June 4th, they were unanimously adopted.

The Select Committee on the G. H. Priest's Address of last session made the following report:

The Committee appointed on the Address of the Grand High Priest, presented at the annual convocation of 1855, have duly considered the points brought to the attention of the Grand Chapter in said address, and offer the following report:

That they believe it necessary that the work in the several Chapter degrees be exemplified at each and every convocation of the Grand Chapter, and they recommend that the Grand High Priest cause the same to be done by the Grand Lecturer, or some other competent companion, in event of absences of the Grand Lecturer, at each convocation of the Grand Chapter, and that the system of work so exemplified, after approval by the Grand Chapter, be adopted as the work of this Grand Jurisdiction.

In regard to that portion of the address relating to ease of emergency, your Committee believe that no such cases should ever be brought to the consideration of a Chapter, and would respectfully recommend that the subordinate Chapters of this Jurisdiction be instructed to confer no degrees on an applicant until he has satisfied the examining Committee of his suitable proficiency in the preceding degrees.

The method of voting by subordinate Chapters, on application for Chapter degrees, is also brought to the attention of your Committee. On careful consideration of the subject, your Committee can see no good reason for objecting to the present method, as approved by this Grand Chapter, which is to ballot for the Royal Arch and preparatory degrees at one and the same time, and would therefore recommend that this practice be considered as the proper mode of balloting in this Grand Jurisdiction.

The last matter brought to the attention of your Committee is the practice prevailing throughout the State of conferring all the Chapter degrees upon a candidate in a single night, if time permits. Your Committee are

opposed to this practice as one totally at variance with the true interests of Royal Arch Masonry, and would recommend that in all cases of advancement the candidate shall first prove to the satisfaction of the Chapter his proficiency in the preceding degrees.

All of which is respectfully submitted.
