RETURNS AND CREDENTIALS.

To the M.E. Grand Chapter of Florida:

Your Committee on Returns and Credentials respectfully submit the following report:

We find the list of Grand Officers and Representatives present as prepared by the Grand Secretary at roll-call to be correct.

We find that the following chapters have made correct returns and paid their dues in full; Nos. 1, 2, 3, 5, 6, 7, 9, 11, 12, 14, 19, 21 and 22, and are therefore entitled to representation and per diem and milage.

Nos. 4, 10, 15 and 20 made returns and paid dues in full but the dues were not paid until after April 1st., and are therefore not entitled to milage and per diem, but owing to the conditions existing at this time we recommend that they be allowed milage

and per diem this year with a distinct understanding that this shall not be considered as a precedent for future action.
No. 8 has made returns but paid no dues. No. 16 paid dues and made returns but failed to affix seal to report.

The Grand High Priest delivered his annual address as follows:

ANNUAL ADDRESS OF GRAND HIGH PRIEST.

Companions of the Grand Chapter of Florida: Although it has been but one short year ago that, in peace, love and unity, we closed the Fifty-Fourth Annual Convocation of the Grand Chapter of Florida, many striking and important changes have taken place, seriously affecting the conditions of many of our companions, neighbors and country; even now we are assembled amidst the ashes and ruins of our once proud and beautiful city of Jacksonville, so recently devastated and destroyed by fire. In this catastrophe can we be of service and aid to those in dire misfortune? Is there a necessity among our companions for practical relief that our means will permit? Knowing that in a few days we should meet in annual convocation, and that all necessities were amply met by the generous tide of incoming contributions from almost every section of our beloved nation, I have not taken upon myself to summarily act on behalf of our organization, and therefore make mention thereof at the very beginning of our present convention, feeling assured that you, dear companions, will take such action as the gravity of the situation and our limited means, financially, will possibly permit.

Amid this scene of ruin and loss there is much to be truly grateful for, in that a kind Providence permitted this awful event to happen at a time when the best things possible to be done under such adverse circumstances could be performed, in great part, in the light of day, and that no greater loss of life ensued. My companions, in the midst of life we are in death. Joy and sorrow are brothers. 'Tis often dark, oh! so dark —then the day, and the sun shines again. Courage, companions, in this your adversity. This dispensation, so grievous, must and can be borne, and out of these ashes of your troubles and sufferings will rise, "Phoenix

like," new and nobler aims and ambitions, loftier purposes, and grander and greater achievements than ever realized in the past.

Since our last meeting we have witnessed the close of the most progressive century of the past, and with renewed hope and courage, steadfast to the principles of our beloved order, in fact one of the great instruments of good to society, we have entered upon the threshold of a new century—the Twentieth Century of the Christian Era. Generally, the surroundings which confront our order, as compared with that of the early part of the last century, are most favorable, and I feel assured that the same firm and courageous devotion to the high principles of Capitular Masonry, which then actuated our early companions, now applied, will accomplish wonders to and for our noble craft.

In the retrospect, an honest contemplation, must confess that our work performed has often fallen below the full measure of our opportunity, capacity and desire.

Our responsibilities are personal in this direction. The Great I AM alone is competent to judge.

Hence; in humble knowledge of the meager achievements of the past year, in this Grand Jurisdiction, as compared with many preceding years, as your Grand High Priest I venture your charitable consideration of the work I bring for inspection, and greet and welcome you to this the Fifty-Fifth Annual Convocation of the Grand Chapter of Royal Arch Masons of Florida.

And first, thankful to God for all that we have received in the past, and with renewed and greater faith in His mercies and blessings for us in the future, it is meet that we should implore His aid in our present undertakings.

Peace and harmony prevail everywhere in our jurisdiction, and Capitular Masonry is awakening from its slumbers, and unmistakable evidences of activity are plainly to be seen. May each of us be filled with the inspiration of such a condition of affairs, and with hope

and energy foster and secure every good that may develop and strengthen our order.

FRATERNAL DEAD.

This Grand Chapter has been visited by the "grim messenger" in the death of R.I.E. Companion R. A. Montsalvatge, who died at his home in Key West. DISPENSATIONS.

To facilitate and promote the best interests of the work in the subordinate chapters, upon application duly made, the causes assigned in each particular case appearing sufficient, I granted the following dispensations:

On June 5th, 1900, I granted a dispensation to Madison Chapter, No. 8, to elect and install its officers at a special convocation.

June 11th, 1900—Granted a dispensation to Jericho Chapter, No. 11, to elect and install its officers, and at its next meeting to elect and install a Secretary.

June 15th, 1900—Granted a dispensation to Mt. Horeb Chapter, No. 6, to receive, ballot and act upon applications for membership, at called meeting on June 22nd, 1900.

July 17th, 1900—Granted a dispensation to Providence Chapter, No. 20, giving them permission to hold a convocation to elect and install officers, and amend by-laws, and to report. (This at the instance of P. G. H. P. Silas B. Wright, to whom this Grand Chapter, at its last convocation, referred certain matters in relation to said chapter.)

January 14th, 1901—Granted a dispensation to Monroe Chapter, No. 15, to hold an election and install officers on January 22nd, 1901.

April 3rd, 1901—Granted dispensation to Island Chapter, No. 21, to ballot on petitions of candidates, at special meeting, Grand High Priest being present, candidates being well known.

April 17th, 1901—Granted dispensation to Madison Chapter, No. 8, to elect its officers and ballot upon three petitions and dimit of Companion Buck, at special meeting on that date, the Grand High Priest being present, and the candidates being well known.

April 22nd, 1901—Granted dispensation to St. Johns Chapter, No. 4, to ballot and confer chapter degrees upon a well-known candidate, at a special meeting, said chapter having failed a quorum at its last regular convocation.

April 22nd, 1901—Granted dispensation to Florida Chapter, No. 1, to ballot upon three petitions of well-known candidates ahead of time, the Grand High Priest being present. (Florida Chapter, No. 1, has a by-law which under ordinary circumstances prevents action at same time petition is presented. Such a by-law being in my opinion within the discretion of said chapter, as contemplated by Reg. 32 of this Grand Chapter, a dispensation was necessary.)

In reference to the granting of dispensations, I have to report that in no case have I considered that the best interests of our craft required that payment for such dispensations should be made, as required by Constitution, Sec. 20, and therefore, in each case, I have remitted such fees.

During an enforced absence from the State of Florida, in attendance upon an invalid mother, the duties of my honorable and high office were ably and acceptably performed by our honored and respected Deputy Grand High Priest, who, for good causes appearing to him granted the following dispensations:

December 3rd, 1900—To St. Johns Chapter, No. 4, to ballot for a well-known candidate at a special meeting.

December 15th, 1900—To Jacksonville Chapter, No. 12, to hold a special convocation to elect officers and transact regular business of chapter.

The fees for these last dispensations have been remitted by me.

Our jurisdiction is so large in its extent of territory; our numbers so small compared with the distance to be traveled, both from chapter to chapter and by members to their chapter meetings; and our membership, with its chapter locations so few and far between, so scattered, it often being very difficult to obtain the necessary quorum for transaction of chapter business; that, to charge a fee for dispensations granted to remedy these lapses in regular order of business would be a burdensome hardship. In our present condition I do not approve this provision of our Constitution.

RULINGS.

Upon request from P. H. P. M. D. Cushing, of Tampa Chapter, No. 3, I ruled as follows: "That in the absence of the High Priest, King and Scribe, of a subordinate chapter, the Junior Past High Priest, pres-

ent, may open the chapter and preside. This to apply to a stated convocation or a special convocation legally called." (Constitution of General Grand Chapter, Article III, Sec. 42.)

BY-LAWS.

After comparing carefully the by-laws of Lake Butler Chapter, No. 19, with our Constitution and regulations, and finding them to be in harmony with the same, I approved them on June 21st, 1900.

CHAPTERS CONSTITUTED.

At the last Grand Convocation of this Grand Chapter a charter was issued to Jericho Chapter, No. 11, at Miami, Fla. On June 11th, 1900, by arrangements made with those interested, it was my privilege to regularly constitute these companions into a regular chapter under this jurisdiction.

In person, assisted by the following companions: J. R. Dewey as Deputy Grand High Priest, W. H. McIntire as Grand Scribe, J. S. Chase as Grand Principal Sojourner, R. J. Chillingworth as Grand Captain of the Host, Thomas Mitchell as Grand Royal Arch Captain, E. H. Rhodes as Grand Secretary, John Kronowetter as Grand Treasurer, C. H. Bradley as Grand Chaplain, and J. D. Girtman as Grand Guard, we proceeded to the chapter room of Jericho Chapter, No. 11, having been notified that its members were ready for our reception, and were received with the grand honors, and filled the stations with the proper officers, and thereupon constituted the members of said chapter (before then under dispensation) into a regular chapter, according to the Ancient Ceremonies adopted by this Grand Chapter.

Thereafter, an election of its officers having been had, I installed into office the following companions: W. W. Faris, as Excellent High Priest; Walter S. Graham, as King; Charles R. Cox, as Scribe; John Thornton, as Captain of the Host; Z. T. Merritt, as Principal

Sojourner; George B. Rumph, Jr., as Treasurer; J. R. Girtman, as Royal Arch Captain; John Douglass, as Master of 3rd Vail; C. B. Munson, as Master of 2nd Vail; Frank B. Wright, as Master of 1st Vail; and John Omweg, as Sentinel.

I delivered to the chapter the regular charge in such cases, and, after benediction by the Grand Chaplain, the Grand Officers retired. After these ceremonies it was my further privilege to officially visit this chapter on the same evening, and witnessed the conferring of all the degrees of the chapter upon two candidates, assisting in the work.

DORMANT CHAPTERS

I have made many efforts to induce the companions of Ocala Chapter, No. 13, to interest themselves in a request for a restoration of their charter, but with indifferent success, local circumstances rendering the present prospect of attaining such a result very doubtful.

In December of 1900 I received a letter, forwarded to me in a far distant State, from Companion W. F. Scott, of Fernandina, for instruction how to proceed to get a restoration of their charter, which by action of this Grand Chapter in the year surrendered its charter. Nassau Chapter, No. 23, having voluntarily surrendered its charter, and the same having been acted upon by this Grand Chapter, in fact forfeiting said charter, I did not consider any prerogative or power to be vested in me in such case, to take any summary action in the premises. I gave the companion instructions to present at this Grand Convocation their petition for a restoration of their former charter, and trust that the same, if presented, will meet with your favorable consideration.

I am delighted to announce that there seems to be an awakening spirit of interest among the companions of our dormant chapters, that promises good to them and satisfaction to our fraternity.

OFFICIAL VISITATIONS.

An important function, freighted with much good to the interest and welfare of Capitular Masonry in this Jurisdiction, was set in motion at our last annual convocation—that of Grand Visitation, by the Grand High Priest, Deputy Grand High Priest, Grand King and Grand Scribe. By regulation then passed, it was made the duty of these officers to make such visitations once at least each year, to such assignments as might be made by the Grand High Priest.

Circumstances, business engagements and absence from the State of Florida conspired to prevent making such assignments by me, until late in our fiscal year, and the fact that such assignment was made so late in the year, I am confident, prevented certain of such visits being so made.

I refer to this, stating the facts of the matter, that those officers upon whom such duty devolved may not be unjustly censured.

Notwithstanding this misfortune, on my part, I am proud to say that this regulation has been so well carried out by all these officers that much good has resulted therefrom in consequence.

Subordinate chapters and the companions heartily appreciate the visits of their highest dignitaries, in their official capacities, no matter how humble and simple their accomplishments may be, and I take pleasure in commenting upon the uniform courtesies, high honors and hearty welcomes extended to these officers in the performance of this line of duty.

We may all profit something from intercourse and companionship, sometimes exquisitely enhanced by the pleasure of greeting some companion upon whose brow has fallen the laurel leaves of our beautiful and benevolent order. The mind broadens, the fraternal sympathies grow nearer and dearer, and brotherly love and tenderness are more apparent. "As one loveth, so is he loved." With the friendly spirit beaming in the face, felt in the hand clasp, and lived in the daily life

and practice of each of us, there cannot long be withstood our efforts for good to our fellow-man.

In accordance with said regulation, I promulgated the following assignment of visitations to be made by said officers:

Dear Companion: Pursuant to a resolution of our Grand Chapter, adopted May 9th, 1900, this Grand Jurisdiction has been divided into the following districts, and the following named officers assigned to such district, for the purpose of visitation, namely:

District No. 1, comprising Chapters No. 1, No. 5, No. 6, No. 8, No. 11, No. 21, and assigned to the Grand High Priest.

District No. 2, comprising Chapters No. 2, No. 4, No. 10, No. 14, No. 15, and assigned to the Deputy Grand High Priest.

District No. 3, comprising Chapters No. 3, No. 7, No. 16, No. 22, and assigned to the Grand King.

District No. 4, comprising Chapters No. 9, No. 12, No. 19, and assigned to the Grand Scribe.

Your Grand High Priest has made an official visitation to the following chapters: Putnam Chapter, No. 9, at Palatka, Fla.; Halifax Chapter, No. 5, at Daytona; Jericho Chapter, No. 11, at Miami (twice), and Island Chapter, No. 21, at Key West. This is the first and only Grand Visitation received by this chapter, and to say that they appreciated this recognition, far away in their beautiful "isle of the sea," does not adequately recognize their extensive and hospitable entertainment given to the Grand High Priest. I was permitted to visit and enjoy for an hour Companion J. W. V. R. Plummer (Deputy Grand High Priest of this Grand Chapter in 1885), who was convalescing from a serious operation, that of the amputation of his right foot. He was doing finely and in reminiscence recalled many happy hours with many of us at our annual convocations.

I visited, also, Madison Chapter, No. 8, at Madison, Fla. This chapter has in common with many of our business interests, in many parts of our State, been suffering from that Masonic depression which accompanies business depression. Long distances for the companions to travel to the place of meetings, the too often "lack of a quorum," and other unavoidable causes incident to our subordinate chapters, have joined in making it impossible to reap the best results possible; but, with the awakening spirit of interest in our order, the outlook is bright, and these companions are now on the road to prosperity and usefulness. They are fortunate in their situation and possessions, and are worthy of the most favorable consideration by us.

Also, Mt. Horeb Chapter, No. 6, at Pensacola, where, amid beautiful natural surroundings and the spirit of fraternal society abundant and overflowing, it would be indeed strange to find other than a wide-awake and successful chapter. These companions are and will ever be an element of strength, beauty and wisdom for Capitular Masonry in that section of our jurisdiction.

I also visited Florida Chapter, No. 1, at Tallahassee, and found them busy, prosperous and happy in the

prospect of much work ahead of them. I assisted in conferring the Mark Master degree upon three candidates, and was informed that they have lately been kept very busy in conferring the chapter degrees upon candidates seeking after light in our mystic circles.

I comment very favorably upon the chapter at Miami, it having been in existence for only one year, and now having a membership (information when last there) of nearly forty members. With members of the abilities, standing and zeal of their character, there are bright prospects ahead for them.

It is unnecessary for me to say of Halifax Chapter, at Daytona, more than that they are in their usual zealous and prosperous condition. I will venture to mention that I enjoyed my visitation there in the most profitable manner, in fact, an intellectual and fraternal treat, for while there was no ritualistic work done at the time, the presence of many visiting companions, bright and instructive in their knowledge of the high principles and practical workings of Capitular Masonry, its aims, hopes, purposes and realizations, and its possibilities to the seeker after truth, made an impression upon me that will ever be remembered.

R. E. Comp. A. M. Cushman reports that on account of his business at the time of receiving his assignment, and since, he had been unable to visit any of the chapters in the Second District assigned, except Gainesville Chapter, No. 2, which he reports in a flourishing condition, as will be seen by the annual returns.

In the Third District, assigned to R. E. Comp. John R. Wetherell, receiving word from him that on account of sickness from grippe he would probably be unable to make such visits, at his timely suggestion I wrote to Past Grand High Priest Warren Tyler, of Bartow, requesting him, as my proxy, to make such Grand Visitations as the limited time would allow. I attach hereto his report to me in full, and express my sincere appreciation for his kind and timely aid in this matter:

Most Eminent Companion: Your request to act as your proxy in visiting the chapters at Orlando, Bartow, Plant City and Tampa reached me on the 3rd of April, and I at once began to make arrangements for official visits to the chapters designated. The time was very short in which to arrange communications for that purpose, but I have succeeded in visiting officially Tampa, No. 3, R. A. M., and Eureka, No. 7, R. A. M.

Having made previous visits to Plant City and being a member of Thomas Brown, No. 22, at Bartow, I can vouch for the good condition of the order at those points, though circumstances beyond my control and that of the companions prevented official visit within the time allowed. The last two chapters have had little work the past year, but have good prospects for the present, and I feel certain the next report will show a material addition to their membership as well as increased proficiency in the degree work.

On April 18th I visited Tampa Chapter, No. 3, and though a severe storm prevented the attendance of the expected candidates, we had a most satisfactory meeting, and the companions exemplified the work in the M. M. degree upon a substitute in a most creditable manner. They now have a good corps of workers and all seem enthused with the spirit of Royal Craft Masonry. They have had twenty convocations the past twelve months and have considerable work in prospect. With the increased accommodations which they will have on completion of their new temple, I look for great strides to be made by the companions at Tampa.

April 26th I visited Eureka Chapter, No. 7, at Orlando, and a most satisfactory exemplification of the work in all degrees was witnessed upon one candidate, occupying an afternoon and evening session. The officers seemed thoroughly conversant with the ritual in all but some minor details, and with the assistance ren-

dered them I feel sure they will become, as they have encouragement to be, one of the brightest and most proficient chapters in the State. Their average attendance, upon the six communications of the past year, was twelve out of a membership of twenty-nine. A banquet followed the night session in the banquet room of their chapter, and several toasts were responded to with many compliments to your representative, which I was sorry you could not have received in person instead of by proxy.

I trust we shall have the pleasure of meeting you in your usual good health next week unless some cause should make it seem more expedient to adjourn the meeting of the Grand Bodies till a later date, on account of the terrible calamity that has befallen our sister city of Jacksonville. Our hearts go out to all our companions and fraters there with deepest sympathy in this their very great misfortune.

As to the Fourth District, assigned to R. E. Comp. T. G. Hutchinson; it was my pleasure to meet him in his official visit at Palatka to Putnam Chapter, No. 9. With him were Companions John H. Norton and William Lansdell, of Jacksonville Chapter, No. 12. He reports that he visited two of the three chapters assigned to him.

Of his visit to Putnam Chapter, No. 9, he says: "February 25th, 1901, I visited Putnam Chapter, No. 9, at Palatka, in company with Comp. J. H. Norton, H. P., of Jacksonville Chapter, No. 12, and Comp. William Lansdell of the same chapter. The chapter was opened in due form, with full quota of officers, in R. A. degree. I inspected the charter, by-laws, etc. Labor work and instruction, and Bro. McLarty advanced to the honorary degree of Mark Master in due form." "I also visited Jacksonville Chapter, No. 12, at Jack-

sonville, Thursday, April 25th, 1901. This chapter is in a prosperous condition, being favored with a good attendance, both officers and members, zealous in their efforts to perfect themselves in our ritual."

At the possible expense of your considering me even too lengthy upon this theme, I will further say that to me this regulation seems a step in the proper direction, tending largely to encourage, foster, cultivate and cement true fraternal knowledge and sympathy among our dear companions in this Jurisdiction, as also to illustrate to companions visiting us on such occasions that we are indeed cultivating and working our fields and vineyards for the best results.

RECOMMENDATIONS.

In quite an extended travel in the performance of my duty, it would appear strange if the mind attuned to the best interests of our craft should not discern something in the existing state of things not in harmony with its thoughts and therefore needing a recommendation in relation thereto, hence I recommend that some regulation tending to constrain our honored Past Grand High Priests to more generally attend our annual convocations be adopted, and suggest such an one as will obviate their necessity of defraying traveling expenses, coming and going, and place them upon the pay roll, with per diem, when in attendance, as other pay officers of this Grand Chapter. I am led to recommend this, not from applications to do so, but from a sincere desire to conserve the wisdom, strength and best interests of this Grand Chapter.

Again, it has always been a matter of regret to me that the time of meeting of this Grand Chapter was severed from meeting at the close of the Grand Lodge of Free and Accepted Masons of Florida. In my humble opinion, many of the inconveniences and unfavorable situations now attending our annual convocations would be removed by a return to the "old way." Certainly, from a financial view, there would be much to gain thereby.

It has come to my knowledge that some of our companions have countenanced the practice of balloting for more than one petition at the same time, "to save time," and in event of a dark ballot then ballot over separately.

To my mind there is no situation, "to save time" or otherwise, that could possibly require such a procedure, and I therefore recommend the adoption of a regulation strongly prohibiting such action under any circumstances. Further comment is unnecessary at this time.

CONCLUSION.

Companions, I am deeply sensible of the distinguished honor conferred upon me, by placing in my hands the authority of the most important and honorable office in your power to bestow.

My only regret is that I could not bring to its service greater ability and a larger portion of my time. Upon such occasions as it has been my privilege to do or say anything for the advancement and good of this great organization, I trust that your generous and keen perceptions will credit me with that true Masonic zeal which should actuate all companions in the discharge of high duties and responsibility.

There is to me a pleasant thought—that all are necessary and useful to fulfill the great purpose and destiny of Masonry, and I have the consciousness of having to the best of my ability, my other duties and demands considered, performed those things which appeared to me best calculated to conserve your best interests.

In closing, I congratulate the companions upon the universally high standard of morality, in precept and example, obtaining among our craft, compared with other benevolent societies. "Virtue alone is true nobility." Fraternally submitted,

Upon motion of M.E.C. Companion Warren Tyler, the Grand High Priest's Address was referred to a Special Committee for the distribution of subjects.

The Deputy Grand High Priest appointed as such committee, Past Grand High Priests Tyler, Wright and Paterson.

The Grand Secretary made the following report, which was received and referred to the Special Committee for distribution of subjects.

GRAND SECRETARY'S REPORT.

To the M.E.C. Grand Chapter of Florida:

Companions: It will be impossible for me to make as complete a report at this time as I had expected and hoped. In our terrible conflagration of the 3rd of this month, the northwest corner of the block in which our temple is located was at one time on fire. As it seemed impossible to check the progress of the flames in other directions, we feared that nothing could save our temple; consequently, I moved out as much as possible of its contents. Let us return our sincere thanks to the great I AM for so mercifully sparing our temple. My papers are at present in such confusion that I trust I may be pardoned if my report is incomplete, and some important matters overlooked.

Providence Chapter, No. 20, at Lake City, has been revived under the direction of Past Grand High Priest Wright, who will no doubt make report of same at this convocation. I have obtained as full a record of its past work as possible, including their return for 1900; but they have paid no dues to the Grand Chapter. I am pleased to be able to say that I have succeeded in getting a complete file of the proceedings of our Grand Chapter, having received copies of the missing number for 1870 from the Grand Chapters of Massachusetts and Minnesota. Our thanks are due to these Jurisdictions for sending us the same.

The thanks of this Grand Chapter are also due as follows:

To Companion George P. Rupp, Grand Librarian of Pennsylvania, for copies of proceedings of his and other Grand Jurisdictions.

To Companion Stephen Berry, Grand Secretary of Maine, for a bound copy of originals of the proceedings of the Grand Chapter of Maine for the years 1855 to 1866. This copy is very rare, and we were indeed fortunate in getting it.

To Companion Gill W. Barnard, Grand Secretary of Illinois, for copy of the history of the Grand Chapter of Illinois; also, for a fine bronze medal of the same Grand Chapter.

To Companion Francis E. White, Grand Secretary of Nebraska, for a copy of our proceedings for 1871.

To Companion Wm. M. McIntosh, Grand Chaplain, for twenty-one copies of back numbers of our proceedings.

It is possible that I have overlooked some who should be remembered; if so, I trust they will consider the circumstances, and take the will for the deed.

As directed by you last year, I made up a list of delinquent representatives, and sent it to the M. E. Grand High Priest on May 26, 1900.

I have discovered the original charter of Thomas Brown Chapter that has been missing for a number of years, and recommend its restoration to that chapter.

A new book for recording chapter charters has been procured, and the record completed as far as it has been possible to obtain the data.

Believing it to be for the best interest of the craft to have a mutual agreement between our Grand Chapter and the Grand Chapters of Georgia and Alabama, in regard to material living near the borders of our respective States, I have taken the matter up with them with the result that the Grand Chapter of Georgia passed the following resolution at its last convocation, on April 24th last:

"Resolved, That the Most Excellent Grand Chap-

ter of Royal Arch Masons for the State of Georgia recognizes concurrent jurisdiction with the Most Excellent Grand Chapter of Royal Arch Masons for the State of Florida of all material residing at or near the boundary line between said States. This resolution to become operative upon the passing of a similar resolution by the Grand Chapter of Florida."

I would earnestly recommend that the Grand Chapter take similar action at this convocation, both as to Georgia and Alabama, as I have assurance from the latter that the matter will receive consideration at their next meeting.

All of the chapters have made returns for 1900, and all have paid dues except Madison, No. 8, Monroe, No. 15, and Providence, No. 20.

The chapters in arrears for dues are as follows:

Companion Wright, no doubt, will make statement as to the dues of Providence, No. 20.

After the terrible experience we have recently passed through, I deem it my duty to earnestly recommend that this Grand Chapter join with the Grand Commandery in the purchase of a suitable fireproof safe for the library. Our most valuable papers and books are now in the Grand Lodge safe, but space there is very limited, and there will soon be no room for any of our books.

I had the entire appendix of our proceedings for this year made up and in type at the printers, all of which has been destroyed by the fire, and will again have to be made up from the returns.

Members of Nassau Chapter, No. 23, have applied for the restoration of their charter, and the papers are herewith presented for reference to the proper committee.

To the M.E. Grand Chapter of Florida:

Your Committee on Unfinished Business respectfully reports that the only unfinished business is the amendment to the Constitution which was proposed by the Committee on Masonic Jurisprudence at the last Grand Convocation which appears on page 31 of the printed proceedings in the following form: "Resolved, That the first clause of Article I, Section 4, of the Constitution of this Grand Chapter be amended so as to read as follows: The Grand Annual Convocations of this Grand Chapter shall be held in the city of Jacksonville on the second Tuesday in May of each year at 10 o'clock a. m. and the Representatives of three chartered chapters shall constitute a quorum; provided that the hour of meeting may be changed by resolution."

A proposed amendment to the Constitution was then offered, and was referred to the Committee on Masonic Jurisprudence.

The motion of Past Grand High Priest Endel prevailed that when the Grand Chapter was called from labor to refreshment it be to meet with Jacksonville Chapter, No. 12, at 7:30 p. m., to witness the exemplification of the work in the first three degrees by the Committee on Work.

The Grand Chapter met with Jacksonville Chapter, No. 12, and witnessed the exemplification of the work in the M. M., P. M., and M. E. M. degrees by the Committee on Work.

MORNING SESSION.

In Grand Chapter,

Wednesday, May 15, 10 o'clock, a. m.

The Grand Chapter was called from refreshment to labor by the M.E. Grand High Priest, with officers and members as at previous session.

The minutes of previous session were read and approved.

The Committee on Masonic Jurisprudence made the following report, which was received and adopted:

MASONIC JURISPRUDENCE.

To the M.E. Grand Chapter of Florida:

Your Committee on Masonic Jurisprudence beg leave to report the matters referred to them as follows:

In relation to the address of the Most Excellent Grand High Priest. It is the sense of your committee that while a dispensation may be properly granted to elect and install officers at a special convocation, yet it is not necessary for a dispensation for such an election, or installation at a regular convocation. As sections 22 and 24 of article 2 of the constitution provides that if such an election and installation be not effected at the convocation preceding St. John's Evangelistic Day, it may be done as soon thereafter as is practicable; therefore, the dispensations granted to Madison Chapter, No. 8, and Providence, No. 20, are approved but the dispensations granted to Jerico, No. 11, and to Monroe, No. 15, were unnecessary under the above constitutional provision.

2. The action of the Most Excellent Grand High Priest in granting dispensations to receive and ballot on petitions at special convocations are approved.

3. The dispensations granted to ballot on petitions short of time by Florida, No. 1, was unnecessary under regulation No. 32, notwithstanding the by-laws of said chapter to the contrary.

4. The remission of a fee for granting a dispensation is left to the discretion of the Most Excellent Grand High Priest, see section 20, article 2 of the constitution, and the action in this respect is approved.

5. The ruling of the Most Excellent Grand High Priest relative to opening a chapter by the former Past High Priest is not approved. Section 38, article 2 of our Constitution provides that the High Priest shall preside, and in his absence the King and Scribe, and no other shall in order of rank succeed him.

6. In reference to the recommendation as to pay for the attendance of Past Grand High Priests on the convocations of this Grand Body, your committee would say that the matter is already provided for. On recommendation of Finance Committee which provided for the remuneration of Past Grand High Priests attending these Grand Convocations in no other capacity. It is recommended that the Grand Secretary have this regulation printed on slips, and attached to the present printed regulations.

7. We approve the ruling of the Most Excellent Grand High Priest in reference to balloting on more than one petition at the same time. We hold it to be unmasonic to do so.

8. Relative to the proposed amendment of section 4, article 1 of the constitution, your committee recommends that the same be amended, so far as the time of meeting is concerned, which shall be fixed for the second Tuesday in May of each year at 10 a. m., so that if amended section 4 shall read as follows:

Section 4. The Annual Grand Convocation of this Grand Chapter shall be held in the city of Jacksonville, on the second Tuesday in May of each year at 10 o'clock a. m., and the Representatives of three chartered chapters shall constitute a quorum. Provided, That the Grand High Priest may, for good cause, designate some other time and place within this Grand Jurisdiction for holding the Annual Grand Convocation. And Provided, also, That the Grand High Priest may call a special Grand Convocation of the Grand Chapter when, in his discretion, it may be necessary or important to do so. And hereafter at the opening of this Grand Chapter, the Grand High Priest shall appoint the following standing committees, each to consist of not less than three members:

1. On Returns and Credentials.
2. On Unfinished Business.
3. On Propositions and Grievances.
4. On Dispensations and By-Laws.
5. On Masonic Jurisprudence.
6. On Finance and Accounts.
7. On Memorials.
8. On Foreign Correspondence.
9. On Printing.
10. On Work, to consist of seven members.

9. Relative to the recommendation of the Grand Secretary as to concurrent jurisdiction with our sister Jurisdictions of Alabama and Georgia, your committee recommend the following resolution:

Resolved, That the Most Excellent Grand Chapter of Royal Arch Masons of Florida recognizes concurrent jurisdiction with the Most Excellent Grand Chapters of Alabama and Georgia of all material residing at, or near the boundary line, between Florida and either of said states, whereby a petition of one residing in such locality may be presented in his nearest chapter.

M.E. Companion Silas B. Wright made the following report on Providence Chapter, No. 20, which was received and adopted:

DeLand, Fla., May, 12, 1901.

To the M.E. Grand Chapter of Florida:

Pursuant to resolutions passed at the last annual convocation I visited Lake City, in June last, and completed arrangements for the revival of Providence, Chapter No. 20, its removal to Lake City, and its consolidation with Columbia Chapter U. D. The old charter was found and most of the books. The members of Columbia Chapter U. D. were elected members of Providence Chapter, No. 20, and council officers elected and installed for the current year. A dispensation was granted for the election and appointment of the remaining officers at a subsequent meeting. Petitions were received and acted upon and twelve candidates were conducted to the ruins and made important discoveries. Several months since, nearly two years, Providence Chapter granted dimits to a large number of members without their having applied for them. This action was clearly illegal. I directed that their names be placed upon the roll and that such as desired be regularly granted dimits, as of new date, and that they be placed on the returns but that the chapter pay no dues for such members for the current year. In consideration of all circumstances and by virtue of the resolution of the Grand Chapter first referred to, I remitted all back dues. This was contrary to my first intentions and expectations but was found necessary in order to get the chapter at work at all.

PROPOSED AMENDMENT TO ARTICLE I, SECTION 4. OF THE CONSTITUTION.

Sec. 4. The Annual Grand Convocations of this Grand Chapter shall be held in the city of Jacksonville, on the second Tuesday of May in each year, at 10 o'clock a. m., and the representatives of three chartered chapters shall constitute a quorum. Provided, That the Grand High Priest may, for good cause, designate some other time and place within this Grand Jurisdiction for holding the Annual Grand Convocation. And provided, also, That the Grand High Priest may call a special Grand Convocation of the Grand Chapter when, in his discretion, it may be necessary or important to do so. And hereafter, at the opening of this Grand Chapter, the Grand High Priest shall appoint the following Standing Committees, each to consist of not less than three members:

1. On Returns and Credentials.
2. On Unfinished Business.
3. On Propositions and Grievances.
4. On Dispensations and By-Laws.
5. On Masonic Jurisprudence.
6. On Finance and Accounts.
7. On Memorials.
8. On Foreign Correspondence.
9. On Printing.
10. On Work (to consist of seven members).

This proposed amendment having been duly ap-
proved by the Grand Chapter, is now published for the
information of all concerned, as the same will come
up for final action at the next Grand Convocation.

REGULATION.

The following Regulation was adopted 1896:

Pay of Officers and Representatives—

Sec. 12. Each officer and one representative of each chapter attending the Grand Convocations of this Grand Chapter, members of the Committee on Work, and Past Grand High Priests in attendance in no other capacity, shall be entitled to receive from its funds such compensation as may be appropriated from time to time by the Grand Chapter. Provided, That no one shall be paid in more than one capacity.

The following resolution was adopted, 1901:

Resolved, That the Most Excellent Grand Chapter of Royal Arch Masons of Florida recognizes concurrent jurisdiction with the Most Excellent Grand Chapters of Alabama and Georgia, of all material residing at or near the boundary line between Florida and either of the said States, whereby a petition of one residing in such locality may be presented in his nearest chapter.

On January 25th, 1902—To Mt. Horeb Chapter No. 6, to ballot on well-known candidates at a special meeting to furnish material for the exemplification of the work.

On March 20th, 1902—To Florida Chapter No. 1, to ballot on well-known candidates at a special convocation.

During my absence from the Jurisdiction the Deputy Grand High Priest reports having granted the following dispensation:

On September 28th, 1901—To Jacksonville Chapter No. 12, to ballot on the petition of a well-known candidate at a Special Convocation.

The fees for the foregoing dispensations have been remitted, having considered that it was for the best interest of the Craft to do so.

DECISIONS.

During the entire year no question requiring official interpretation of Masonic or Capitular Masonry, has been propounded to the Grand High Priest.

This is an indication that the rules of Masonic jurisprudence are more securely and widely known than heretofore, and I congratulate the Royal Craft upon the fact that it evidences a high order of intelligence among the officers and companions of the several Chapters, and they are to be commended for their zeal and energy in acquiring a thorough knowledge of our regulations.

DEFUNCT CHAPTER.

Shortly after the session of the Grand Chapter, I engaged in correspondence with the officers of Ocala Chapter No. 13, with the determination, if possible, to effect its reorganization and reinstatement, and receiving the apparently sincere assurances of these Companions of their desire to rehabilitate Royal Arch Masonry in that community, I directed the Grand Secretary to restore the Charter upon the proper application of nine or more former members, and the payment of \$25.00, which fee was based upon their representation of a fair valuation of the paraphernalia belonging to the Chapter.

On August 1st the Charter was accordingly restored, and I was caused gratification and pleasure at the prospects of a vigorous and influential Chapter being re-established in that important section of our Jurisdiction.

Our efforts, however, were doomed to disappointment and regret, for, notwithstanding their solemn covenant to successfully, zealously and conscientiously maintain the new Chapter, it soon became evident that the proper material was lacking, and that the long-continued apathy that had previously prevailed had secured so strong a foothold, that the few companions who evidenced the desire to faithfully perform their duties, were unable to combat with this condition. The Chapter held but one Convocation, and thereafter they report the impossibility of materializing a quorum.

Upon receiving notice from the Grand Secretary that this Chapter had returned to his office the blank returns with the announcement of their inability to continue, and recognizing the futility of further effort in that direction, I ordered the Grand Secretary to demand the return of the Charter, and the delivery of the effects and assets of said Chapter to the Grand Chapter.

On May 26th, in accordance with the regulation as adopted in 1900, I promulgated the assignment of visitations for the Grand Officers as follows:

First District—M.E., Grand High Priest.

Second District—R.E., J. R. Wetherell, Deputy Grand High Priest.

Third District—R.E., T. G. Hutchinson, Grand King.

Fourth District—R.E.: Louis C. Massey, Grand Scribe.

REPORT OF THE DEPUTY GRAND HIGH PRIEST.

A. M. Cushman, Esq., M.E.: Grand High Priest:
Yours of May 26th was duly received, allotting to me Chapters Nos. 4, 5, 11, 15 and 21 for official visitations.

On January 28th I visited Jericho Chapter No. 11, at Miami.

In the afternoon we held an informal meeting, as not enough companions were present to open a Chapter. A couple of hours were spent very profitably. Nearly all of the officers-elect were present, and were zealous to perfect themselves in the duties of their respective offices.

At the regular convocation in the evening, I installed the officers, and afterwards assisted in conferring the R. A. Degree. Much interest was manifested by the Companions, who gave me a cordial welcome. I am pleased to report the Chapter flourishing. Although the youngest in the State, the membership is excelled by but few, and with an effort of the officers to "post up," I predict a brilliant future for the most southern Chapter on a railroad in the United States. The records I found neatly kept, and the finances flattering.

On March 13th I paid a visit to Halifax Chapter No. 5, at Daytona, where I was royally welcomed by the Companions.

In the afternoon I assisted in conferring the M. M., P. M. and M. E. M. Degrees and in the evening the R. A. Degree on three highly intelligent and appreciative candidates.

Any compliments to Halifax Chapter, the home of P. G. H. P. James Carnell, would be superfluous. Perhaps no Chapter in the State confers the Degrees with greater proficiency.

A number of distinguished visiting Companions from the North (winter residents) were present, and after work, several favored us with eloquent remarks. A banquet followed. The neatly written records spoke plainly how well the Secretary did his duty, and I was pleased to hear a good financial report.

Daytona is on a boom and Masonry shares in the prosperity.

The Chapter exalted thirteen candidates during the year.

April 22d found me in Sanford on a visit to Monroe Chapter No. 15. I had deferred visiting this Chapter for some time, hoping they would have work. A goodly number of the Companions were present, but unfortunately we had no candidate, although the Excellent High Priest had exerted himself in that direction.

The Chapter had elected candidates, but they being railroad men, were away from home. We spent the evening in a general conversation on the work. Many of the Companions asking questions, thus eliciting considerable interest, and drawing out information valuable to all. Monroe Chapter has the finest and best furnished Chapter room that I have visited.

Records and finances were in good condition.

St. John's Chapter No. 4, at DeLand, I often visit.

This Chapter has not had as much work the last year as some years in the past, yet the Chapter is prosperous, and none in the State contains more zealous and better posted Masons who labor for the high and noble principles of Capitular Masonry.

I regret to say that owing to the distance, and the expenses attending thereto, I have been unable to visit Island Chapter No. 21, at Key West.

One feature that I deplore, and have condemned, is the use of cipher books in the Chapters. While they are valuable aids to the memory, I do not think they should ever be used in open Chapter.

Among other suggestions I have made to all the Chapters, I have suggested the desirability of carrying a reasonable amount of insurance.

REGULATION.

RESOLUTION ADOPTED MAY, 1902.

The resolution in regard to concurrent jurisdiction between the States of Georgia, Alabama and Florida adopted in 1901 was amended to read as follows:

Resolved, That the Most Excellent Grand Chapter of Royal Arch Masons of Florida recognizes concurrent jurisdiction with the Most Excellent Grand Chapter of Georgia of all material residing at or near the boundary line between Georgia and Florida, whereby a petition of one residing in such locality may be presented in his nearest Chapter.

In regard to concurrent jurisdiction with the Grand Chapter of Alabama the following resolution was adopted:

Resolved, That this Grand Chapter recognizes concurrent jurisdiction with the Grand Chapter of Alabama over all material residing within five miles of the State line, provided there be no organized Chapter of his own Grand Jurisdiction within ten miles of petitioner's residence.

Amendment to Article 1, Section 4, of the Constitution adopted May, 1902:

Section 4. The Annual Grand Convocations of this Grand Chapter shall be held in the city of Jacksonville, on the second Tuesday of May in each year, at 10 o'clock A. M., and the representatives of three chartered Chapters shall constitute a quorum. *Provided*, That the Grand High Priest may, for good cause, designate some other time and place within this Grand Jurisdiction for holding the Annual Grand Convocation. And *provided, also*, That the Grand High Priest may call a special Grand Convocation of the Grand Chapter when, in his discretion, it may be necessary or important to do so. And hereafter, at the opening of this Grand Chapter, the Grand High Priest shall appoint the following Standing Committees, each to consist of not less than three members:

1. On Returns and Credentials.
2. On Unfinished Business.
3. On Propositions and Grievances.
4. On Dispensations and By-Laws.
5. On Masonic Jurisprudence.
6. On Finance and Accounts.
7. On Memorials.
8. On Foreign Correspondence.
9. On Printing.
10. On Work (to consist of seven members).


