

The M. E. Grand High Priest delivered the following address:

GRAND HIGH PRIEST'S ADDRESS

*Companions of the Most Excellent Grand Chapter of
Royal Arch Masons of the State of Florida:*

We meet here, my companions, in a happy re-union, at which we are once more permitted to clasp the brotherly hand and look into the friendly eye, and I welcome you most heartily to this Grand Convocation, the sixty-sixth in the history of the Royal Craft in this Grand Jurisdiction. These are indeed pleasant occasions when we are privileged to renew the acquaintanceships and the friendships that are in a measure interrupted by the calls of business and the necessities of life. Let us make the most of the opportunity to cement those chains of brotherly love and affection which peculiarly mark our beloved fraternity.

We, to whom you have given authority to represent you and to transact your business for you during the year that has just passed, are here to give you an account of our stewardship.

The year has been one of quiet work, with an advance in membership, but with no important questions arising between the companions of this jurisdiction that has in the least marred the peace of the fraternity. We have dwelt in peace among ourselves and with all our sister jurisdictions with whom we are in fraternal relations. For this and all other blessings, for which we are so much indebted, let us give devout and heartfelt thanks to the great I Am, the giver of all good things.

While we rejoice in the prosperity of our fraternity, and in the prosperity and well-being of all members of the Royal Craft in this Grand Jurisdiction, let us not fail to remember those who have, during the year, been called into that land where our fathers have gone before us.

Death has not removed any of the officers of this Grand Chapter during the past year, but he has laid his icy hand on two of our Most Excellent Past Grand High Priests, and they have obeyed the summons and have passed beyond the veils from our mortal sight.

On January 2nd, M. E. Companion William Henry Jewell, P. G. H. P., died at his home in Orlando. Companion Jewell was a striking and welcome figure at our last Grand Convocation, as he had been for many years before. While he was verging on that period which we term "old age," yet none of us but hoped and believed that he would be spared to us for many years, to give us counsel and advice and to charm with his presence the gatherings of his brethren and companions.

Companion Jewell was exalted to the Royal Arch degree in Orlando, July 19, 1887, and was Grand High

Priest of this Grand Chapter for the year 1896. He has occupied many exalted stations in every branch of the craft, the duties of which he discharged with great ability and with zeal for the welfare of the craft. In his daily life Companion Jewell was the soul of honor. He gave distinguished proof of his courage and patriotism at a time when men's souls were tried in the fiery furnace of civil strife, and in every walk of life exemplified those virtues which we are taught as Masons to practice. May we not say of Companion Jewell, as was asked by the prophet of old, "Know ye not that a great man has fallen in Israel this day?"

Immediately upon the receipt of the telegram from the Grand Secretary, announcing the death of Companion Jewell, I wired M. E. Companion Warlow, asking him to bear my condolence to the family of our late companion and to represent me at the funeral services. A proper floral offering was sent from this city by our Grand Secretary, anticipating my desires in the matter.

On April 24th I was advised by a wire from the Grand Secretary of the death of M. E. Companion Michael Bowes, P. G. H. P., which occurred in Raleigh, N. C., on April 23rd.

Companion Bowes was Grand Scribe of this Grand Chapter for the year 1869. He served as Grand High Priest for the years 1873 and 1874. The roster of Grand Officers furnishes no further information as to his Masonic history.

Immediately upon the receipt of the telegram from our Grand Secretary, I wired to Companion J. C. Munds, Grand Secretary of the Grand Chapter of North Carolina, asking him to take such steps as were possible and to have an appropriate floral offering placed upon the coffin of our late most excellent companion.

I have not been advised as to what has been done.

In the very early hours of Monday morning, April 15th, there went down in the icy waters of the Atlantic Ocean the greatest ship ever yet constructed by the skill of man. With her went fifteen hundred people whom it was not possible to save.

On that night of horror many deeds of heroism were done that have added glory to the name of manhood and womanhood. Unselfish love and fearlessness in the face of death characterized the men and women on the fated vessel, who so calmly went to their death.

Among those who immortalized their names by cheerful and unflinching courage, was a Royal Arch Mason of this Grand Jurisdiction.

Companion Robert J. Bateman, a member of Jacksonville Chapter No. 12, having an opportunity to enter one of the boats that finally reached safety, refused the offer and, placing a woman relative in the boat, smilingly returned and shared the fate of his fellow passengers, and we cannot doubt that he was sustained in those last moments by an unfaltering trust in the All-Wise Creator and that he devoted those last moments in caring for and encouraging those about him.

Masonry has always taken care that the name and the fame of her heroes be preserved. Our Companion Bateman was a hero and in his death exemplified the best teachings of the great fraternity.

In the preparation of memorials of the dead, Companion Bateman should not be forgotten by this Grand Chapter, and it would seem that this Grand Body might, with propriety, appropriate a reasonable sum to assist in raising any memorial to him that may be contemplated by the fraternity of Masons.

NECROLOGY

In commemorating the lives and virtues of our own dead, let us sorrow with those who mourn in other Grand Jurisdictions.

VISITATIONS

During the early part of my term, and in accordance with Regulation No. 28, I divided the Grand Jurisdiction into four divisions, making the following assignments:

M. E. Grand High Priest—Halifax, No. 5; Jericho, No. 11; Jacksonville, No. 12; St. Augustine, No. 17; Island, No. 21; Lake Worth, No. 24; Indian River, No. 27; Joppa, No. 28.

R. E. D. Grand High Priest—Gainesville, No. 2; St. John, No. 4; Eureka, No. 7; Ocala, No. 13; Monroe, No. 15; Nassau, No. 23; Putnam, No. 9.

R. E. Grand King—Florida, No. 1; Mt. Horeb, No. 6; Lake Butler, No. 19; Live Oak, No. 25; Jefferson, No. 26; Gadsden, No. 30; Jackson, No. 32.

R. E. Grand Scribe—Tampa, No. 3; Dade City, No.

8; Jasper, No. 10; Inverness, No. 14; Plant City, No. 16; Manatee River, No. 18; Thomas Brown, No. 22; Lakeland, No. 29; St. Petersburg, No. 31.

Outside of my own Chapter, Jericho No. 11, I have been able to visit only two of the Chapters assigned to the Grand High Priest.

Jericho Chapter No. 11 has had a prosperous year under careful and efficient officers. It is well equipped with paraphernalia and the books and accounts are well kept under the eye of a vigilant and efficient High Priest.

I visited Island Chapter No. 21 at Key West. Owing to an error in the date of meeting of the Chapter, the time selected was a night on which there was no meeting. The Companions, however, rallied to the Grand High Priest, displayed their equipment and books and accorded me every opportunity of examining into the condition of the Chapter. Later in the evening a banquet was proposed and enjoyed by a number of Companions.

I had the pleasure, also, of making an official visitation to Lake Worth Chapter, No. 24, at West Palm Beach. I was received with honors, and assisted in conferring the P. M. degree on two candidates. The Chapter is doing considerable work, is laboring unitedly and is in good financial condition.

I am convinced from my experience of four years that our system of dividing the state into four districts, assigning one to each member of the council, is an expensive and inefficient way of Chapter supervision. In the thickly settled portions of the state the system may work excellently, but for the most part the Chapters are situated long distances apart, and it is almost impossible for even the most energetic officer to get to every Chapter. The division of the state, as made for this year, and it was the best that I could devise, assigned to the

Grand High Priest a territory 516 miles long, in which there are eight Chapters. Inevitably, the attempt to reach these Chapters, from any point, involves a very large expense.

Chapters ought to be visited regularly by some Grand Officer. The effect of an official visitation, in my judgment, is always good; but some means should be adopted that will not take up so much of the time of the official making the trip and which will not bear so heavily in the way of expense on the individual Chapters.

DEAR SIR AND COMPANION—I have the honor to report that I have made the following official visits to the Chapters you assigned me.

June 5th, 1911, by request of Grand Secretary, I went to Dade City and instituted Dade City Chapter No. 8. Delivered their charter and installed all their officers, I also gave them necessary instructions about books, records, etc., and left them prepared to do good work.

September 11, 1911, I visited Lake Butler Chapter No. 19, found a large attendance, and an all-day meeting. They had work in the Mark and P. M. degrees on several brothers. They told me that they had three teams on the way for the Royal Arch. They seemed very hopeful for the future. I found their books in good shape. on hand, ready to assist at the banquet as well as the work. They had two teams for the R. A. degree. By special request, Comp. Carnell acted as P. S. I found their books and records neatly and correctly kept. This Chapter is in a prosperous condition. Convocation closed with a banquet, there being 35 present.

March 15th. I designated this date as the time for my official visit to my own Chapter, Gainesville, No. 2. I have attended all the meetings of this Chapter and report them in a growing and prosperous condition, with a number of candidates on hand.

March 19th I visited Eureka Chapter, No. 7, Orlando. This is the home of two P. G. H. P. Comps., L. C. Massey and T. Picton Warlow. A feeling of sadness came over me because of the absence of our lamented P. G. H. P. and Masonic Genius W. H. Jewell. The work for the evening was in the Mark and P. M. degrees. I found their records well kept. Refreshments were served at the close of meeting.

March 22nd I visited Ocala Chapter, No. 13. They had work in the Mark degree. I found their books and records well kept. They have several candidates in line. My tour of the Chapters was very pleasant, each Chapter trying to excel in my entertainment. I found it necessary to offer some corrections and give some instructions, which were well received.

I have not been able to make a date with Nassau or Sanford Chapters.

DEPUTY GRAND HIGH PRIEST

Immediately after the closing of the last Grand Convocation of this Grand Chapter, I left the Grand Jurisdiction on my annual vacation. On my return in the early part of June Deputy Grand High Priest Robert McClellan made the following report:

Dear Companion—In reply to yours of 10th inst. would say that I signed some warrants sent me by Grand Secretary, and at his request, I went to Dade City June 5th, 1911, and instituted that Chapter and installed their officers, and gave them dispensation to elect a Secretary and Treasurer so that they could all start off together, and gave them all needed instruction for running the Chapter.

They had lost or mislaid dispensation for U. D. but they gave me, upon request, a certificate agreeing to send it in to you if they ever find it. So I delivered charter with that understanding. The certificate I sent in to Grand Secretary.

DECISIONS

1. On October sixth, 1911, I received a telegram from the Secretary of Mt. Horeb Chapter No. 6, at Pensacola asking for a dispensation to ballot short of time. My reply was that the matter was within the discretion of the Chapter.

2. Florida Chapter, No. 1, at Tallahassee, transmitted to me certain papers received by that chapter, asking contributions by the chapter for the purpose of raising money to build a fence around the property of the Johnson Island Confederate Masonic Cemetery Association, and whether the funds of the chapter could be expended for that purpose without the permission of the Grand High Priest.

I replied, that while I was in sympathy with every movement looking toward the care of the places of burial of the dead, and that I deeply sympathized in the purposes of the Daughters of the Confederacy, who made the appeal, in perpetuating the memories of those who had fallen in war, it was my judgment that there was no authority for using Chapter funds for the purpose indicated.

3. The Treasurer of Lakeland Chapter No. 29, having died, I was applied to for a dispensation to elect a Treasurer. The chapter was referred to Section 12 of Article 1v of the Constitution.

Dade City Chapter asked that a Companion whose name was accidentally omitted from the charter of the chapter, have his name recorded as a charter member. As this was a matter, more of bookkeeping than law, I referred the papers to the Grand Secretary, with the request that the name be inserted as requested, providing that it did not entail too much labor upon his office.

I did this because I know that many of our Companions highly esteem the honor of being known as a charter member of a lodge or chapter and I was disposed to accommodate the Companion if it could be done without entailing too much labor on the books of the Grand Secretary.

I was asked to approve the by-laws of St. Petersburg Chapter, No. 31, but as there were several provisions which conflicted with the constitution and regulations of the Grand Chapter, I returned them with instructions to make the changes suggested. I have not again received the documents.

I approved a by-law of Jericho Chapter, No. 11, raising the dues from two to three dollars per year.

APPOINTMENT OF REPRESENTATIVES

On November 15, 1911, at the recommendation of the Grand Secretary of the Grand Chapter of the State of New York, I appointed E. Companion Daniel E. Jones, P. H. P., of Hudson River Chapter, No. 262, at Watervliet, that state, to be the representative of this Grand Chapter near the Grand Chapter of New York, in the place of R. E. Companion James W. Morange, deceased.

Death having removed our representative near the Grand Chapter of Iowa, Companion G. R. Turner, on the 7th day of March, 1912, I appointed, at the recom-

mendation of the Grand Secretary of the Grand Chapter of Iowa, Companion A. D. Meeker, to be our representative there.

April 30th, 1912, Companion Grosscup, heretofore our representative near the Grand Chapter of New Jersey, having resigned his commission, at the recommendation of the Grand High Priest of the Grand Chapter of New Jersey, I appointed E. Companion Lorenzo D. Sanborn, of Harrison, N. J., the present Grand King of the Grand Chapter, as the representative of this Grand Chapter.

INVITATIONS

On October 16, 1911, I received the following communication:—

Kindly advise me at your earliest convenience in order that we may make hotel reservations for you.

I promptly accepted the invitation and made preparations to be present at what I knew would be a pleasant and instructive occasion, but at the last moment much

to my disappointment I was prevented from attending by severe illness.

I also received a very kind and courteous invitation to attend the twenty-second annual banquet of the Fraternal Union of Anointed High Priests at New York City on May 1st, but was not able to accept on account of pressing business.

SURRENDERED CHARTER

R. E. Grand Scribe Caldwell notified me, on December 28, 1911, that owing to severe losses in membership, Jasper Chapter No. 10, had met, paid all bills and dues owing to this Grand Chapter, and surrendered its charter.

I directed our R. E. Companion to take charge of the books, paraphernalia and property of that chapter, and hold the same at the disposal of the Grand Chapter.

LOAN

The Grand Treasurer having notified me, on June 10, 1911, that he had an opportunity to loan the Grand Lodge of Florida at 5 per cent. per annum some of the funds of this Grand Chapter which were at that time drawing four per cent, I authorized the loan of such of the funds of the Grand Chapter as were then available, taking therefor the authorized obligation of the Grand Lodge.

APPOINTMENT

The death of our M. E. Companion Jewell caused a vacancy in the committee on work of this Grand Chapter, and I appointed M. E. Companion J. H. Weddell as Chairman of the Committee, and also appointed E. Companion C. S. Bonacker to fill that vacancy.

CONCLUSION

This, Companions, is the record of the work of the past year. I would be extremely remiss in my full duty if I were to omit the expression of my gratitude to those distinguished Masons, my fellow Grand Officers, who have given so liberally of their time and their talents for the transaction of the business of the Grand Chapter. Their loyalty and courtesy to the Grand High Priest, during his term of office, has been one of my chief pleasures of this past year and will linger in my memory as one of the principal rewards of the high office.

Especially am I indebted to the Grand Secretary, who is a sure rock of safety to any Grand High Priest, and who during the past year has materially lessened the burdens of the office by his promptness and thorough efficiency.

I give you back your trust, my companions, with the hope that no act of mine, either of omission or commission, has derogated from the dignity or the usefulness of this splendid office. I trust that what little I have been able to accomplish will have been for the lasting benefit of the Royal Craft, and in laying down the office of Grand High Priest, I gladly resume my place among the companions from whom I have, at all times, received so much courtesy and honors.

Upon motion of M.:E.: Silas B. Wright, the foregoing address was referred to a special Committee for distribution of subjects, etc., the R.:E.: Deputy Grand High Priest appointing as such Committee M.:E.: Past Grand High Priests Silas B. Wright, James Carnell and Louis C. Massey.

Upon motion of M.:E.: I. E. Webster, all Royal Arch Masons in good standing were invited to attend the sessions of this Grand Chapter.

The Grand Secretary made the following report which was received and referred to the Special Committee on Distribution.

GRAND SECRETARY'S REPORT

To the M.:E.: Grand Chapter of Florida:

COMPANIONS: I have the honor of reporting matters pertaining to the Grand Secretary's office for the past year as follows: Five hundred copies of the proceedings of our last Annual Convocation were printed and distributed in the usual manner.

A proclamation issued by M.:E.: Nathan Kingsley, General Grand High Priest, on October 6, 1911, states that the Grand Chapter of Royal Arch Masons of Utah was regularly organized on September 5, 1911 with C. F. Jennings, Grand High Priest and William J. Shealy of Salt Lake City, Grand Secretary, and a request for Fraternal recognition and exchange of representatives has been received from that Grand Chapter. Both of these documents are herewith submitted.

As our Grand Lodge has made it a practice to furnish blanks to its Lodges, we are constantly receiving requests for blanks from our Chapters. Some years since the Grand Chapter voted not to supply blanks to its Chapters. In my opinion the time has now come when we should at least furnish blank petitions for the degrees and possibly dimits. It would entail but little expense upon the Grand Chapter and I feel that we are abundantly able to do so. In accordance with your instructions, a Past Grand High Priest's jewel has been procured for M.:E.: Companion Frank B. Stoneman and same is ready for presentation at the proper time.

The charter of Providence Chapter, No. 20, at Lake City having been arrested by you last year, I have made every effort to secure the books and accounts of same so as to enable me to issue certificates to its members that would enable them to petition for affiliation with other Chapters, but have failed to get them. The only way to accomplish this, in my opinion, would be to send one of our Grand Officers to Lake City for them and I would suggest that this be authorized.

I am sorry to have to report that Jasper Chapter, No. 10, surrendered its charter on December 27, 1911. The books and returns have been received at this office.

Returns have been received from Lake Butler Chapter, No. 19, but no dues for the years 1910 and 1911. I have received several complaints from members of that Chapter stating that they were unable to get receipts for dues or dimits. One complaint being

from Companion R. L. Anderson of Plant City. Letters and replies are herewith submitted. It may be necessary to take some action in regard to this Chapter at this time.

Indian River Chapter, No. 27, has made correct returns for 1911 and paid its dues with the exception of \$1.00, but notwithstanding the fact that numerous letters were written to the Secretary and High Priest of this Chapter calling their attention to the fact that unless returns and dues were received on or before April first in accordance with our regulation, their representative could not be paid for attendance upon this Annual Convocation of the Grand Chapter, their returns were not received until more than a week after that date.

Inverness Chapter, No. 14, has made correct returns for 1911, but has paid no dues.

Manatee River Chapter, No. 18, has made correct returns, but is still due \$4.00.

Island Chapter, No. 21, has made correct returns, but is still due \$5.00.

Thomas Brown Chapter, No. 22, has made correct returns, but is still due a balance of \$8.00

The War Department of the United States has made and enforced a regulation prohibiting the inscription of any insignia or emblem of any fraternal or secret society on any of the monuments, or tombstones, in the National Cemetery of the United States.

Mr. Harrison of Mississippi has introduced a joint resolution in the House of Representatives directing the Secretary of War to permit such emblems or insignia to be inscribed on monuments or tombstones in the National Cemetery.

A number of Grand Lodges and other Masonic bodies are taking this matter up trying to bring influence to bear to have this resolution passed. It may be well for this Grand Body to take some action in this matter.

It is true that the division of this large state into four districts makes a heavy demand upon the time of the said officers, and upon the treasuries of the subordinate Chapters. But your committee feel that it is the reluctance of the Grand Officers to put the Chapters to expense sometimes grudgingly contributed, rather than the want of time, which renders the present system unsatisfactory. And it is by no means clear that the subordinate Chapters should be individually put to this expense. The visitations are for the general good of Capitular Masonry, the Grand Chapter funds are contributed by the subordinate Chapters and ought to be expended for their benefit in the discretion of the Grand Chapter.

Your committee, therefore, recommends that the present system of supervision be continued and that the necessary traveling expenses of the officers making the visitation be paid from the treasury of the Grand Chapter upon warrants drawn in the usual way, and that the Committee on Finance and Accounts be instructed to include in their report an adequate appropriation for the purpose.

MEMORIALS

The hour of 12:00 M., which was made a special order for report of the Committee on Memorials, having arrived, Companion W. R. O'Neal, Chairman, in presenting the report, said in part:

Most Excellent Grand High Priest and Companions of the Grand Chapter of Florida: It is fitting that we should pause for an hour at this time to pay tribute and to do honor to the Companions who have obeyed the last summons, since our last Convocation. While each of the companions has filled his place in our circle and has performed his part in life, three of our members are entitled to and should receive more than a passing notice. Robert J. Bateman, who bravely met death on the ill-fated "Titanic," Past Grand High Priest, Wm. Henry Jewell, who on January 2, 1912,

was called to his reward, and Past Grand High Priest Michael Bowes, who died on April 23, 1912.

In every generation there stands out among those we know, one who is recognized from every point of view as being an unusual man. Such a one was General Jewell. He was dignified in his bearing, forceful as a speaker, pleasant in his greetings, gentle as a woman, broad in his sympathies, his life was a living illustration of that broader selfishness which was not for self alone, but included all those with whom he came in contact. His life on this earth is ended; the places that once knew him will know him no more, but could we with far-seeing eyes pierce the veil that divides this world from the other, I am sure that we would know that he has entered into that larger life of usefulness for which this is but a preparation, and although we shall meet him no more here, his works do follow him.

To the M. E. Grand Chapter of Florida:

Your Committee on Memorials respectfully submit the following report:

An examination of the returns from the different Royal Arch Chapters throughout the state shows that thirty Companion Royal Arch Masons, representing eighteen Royal Arch Chapters, have passed through the valley of the shadow of death since the close of our last Annual Convocation and their seats have been left vacant.

These frequent visits of all-conquering death are constantly reminding us that we are mortal and it is appropriate and proper that the regular business of the session be suspended for a brief time, so that suitable tribute of respect and esteem may be paid to the departed ones who have entered upon that sad journey which sooner or later we must all pursue.

Among the departed ones were two Companions, who in years past have received the highest honors this Grand Chapter could bestow upon them.

Companion Michael Bowes was for many years a member of Jacksonville Royal Arch Chapter, No. 12, and as E. High Priest, represented that Chapter in this Grand Chapter. He was elected and served as Grand Scribe in 1869, and as Grand High Priest in 1873 and 1874. He discharged the duties and responsibilities of these high offices with zeal and fidelity. Later in life he removed from this Grand Jurisdiction and spent the latter years of his long and useful career in Raleigh, North Carolina, where he enjoyed the regard and esteem of the Royal Arch Masons of that city and died, honored and lamented, on the 23rd day of April, 1912.

Companion William Henry Jewell was better known to those who have been in attendance upon our annual convocations during the past twenty years. As a member of the Committee on Work, he took an active part in the exemplification of the Chapter degrees. Those of us who have seen him take the lead in the exemplification of the degree of M. E. Master will always remember the beautiful and impressive manner in which he conducted the ceremonies. He was born in the state of Massachusetts and was brought

up in the state of Mississippi, where his home was when that state passed an ordinance of secession and, being in sympathy with the sentiment which prevailed in his adopted state, he enlisted in the Confederate army and served till the close of the war. He afterwards made his home in Orange County, Florida, and was admitted to the bar in 1885. He was initiated, passed and raised in Bovina Lodge, No. 112, at Bovina, Mississippi, in 1869 and 1870, and when he came to Florida he united with Orlando Lodge, No. 69, in 1886, and was chosen as Worshipful Master in 1901. In 1887 he was exalted to the august degree of Royal Arch in Eureka Chapter, No. 7, in Orlando, and was afterwards advanced to some of the higher degrees in Masonry. In the Grand Chapter he served as Grand King in 1894, as Deputy Grand High Priest in 1895 and as Grand High Priest in 1896.

He always took a great interest in preserving the memories of the late war and in cherishing the ties of friendship with his old comrades in arms and became a prominent member of the United Confederate Veterans, of which organization he was chosen Major General of the Florida Division in 1906 and at the end of his term was made Honorary Commander for life.

In civil life he was a citizen of the highest type and discharged his duties with distinguished ability when charged with the responsibilities of public office. As a representative of Orange County in the State Legislature, and as Mayor of Orlando, he rendered valuable services to his people and has left a record for integrity and faithfulness to be treasured by his family and friends.

Companion Jewell died at his home in Orlando, January 2, 1912. He was a gifted man; he had the pen of a ready writer and an eloquent tongue; he was courteous to all with whom he came in contact, generous to the unfortunate, true to his friends, faithful in every relation of life, and he died lamented by his family, his friends and associates. It has been well said "the good man never dies," and Companion Jewell still lives with us in the sweet memories of his useful life and the love he felt for his fellowmen.

Besides the long list of the Companions of our own Jurisdiction who have entered upon the life elysian, the M. E. Grand High Priest states in his annual address that twenty Companions in sixteen other Grand Jurisdictions, who have been honored with high positions in their several Grand Chapters, have also crossed the dark stream which separates time from eternity.

In all of these cases, whether in this or other Grand Jurisdictions, we mingle our sorrow with the bereaved ones and desire to pay a suitable tribute of respect to the memories of our departed Companions.

The committee therefore recommend that the necessary number of pages in our proceedings be set apart as memorial pages, one for the deceased in our own Grand Jurisdiction, and one for those in other Grand Jurisdictions mentioned in the address of the M. E. Grand High Priest, and one each for Past Grand High Priests Bowes and Jewell, the same to be suitably inscribed by the Grand

Secretary with the names, rank and dates of the decease of our departed companions.

MASONIC JURISPRUDENCE

To the M. E. Grand Chapter of Florida:

The Committee on Masonic Jurisprudence respectfully submit the following report:

The decisions of the M. E. Grand High Priest are in accord with the constitution and ruling of the Grand Chapter and are approved, but as no new principles of Masonic law are involved we do not consider it necessary to have them reported and entered as new regulations.

The failure of Lake Butler Chapter, No. 19, to pay its dues for 1910 and 1911, and the present conditions of the Chapter reported by the Grand Secretary has been considered and the committee recommend that the Charter be declared forfeited according to Section 5 of the Constitution, and that authority be given to the incoming Grand High Priest to restore the Charter upon payment of the dues for the years 1910 and 1911, provided he is satisfied that the best interests of Royal Arch Masonry will be advanced by the continued existence of the Chapter.

It is recommended that the Grand Chapter R. A. M. of Utah be recognized and that there be an interchange of Grand Representatives with this Grand Jurisdiction.

It is recommended that the Grand Chapter approve the Resolution introduced into the House of Representatives in Washington authorizing the repeal of the law prohibiting the inscription of any

insignia or emblem of any fraternal or secret society upon any monuments, tombstones or slabs in the National Cemetery of the United States.




