MASONIC CALENDAR

Ancient Craft Masons commence their era with the creation of the world, calling it ANNO LUCIS (A.L.) "in the year of light."

Scottish Rite, same as Ancient Craft, except the Jewish chronology is used, ANNO MUNDI (A.M.) "in the year of the world."

Royal Arch Masons date from the year the second temple was commenced by Zerubbabel, ANNO INVENTIONIS (A.I.) "in the year of the discovery."

Royal and Select Masters date from the year in which the temple of Solomon was completed, ANNO DEPOSITIONIS (A. Dep.) "in the year of the deposit."

Knights Templar commence their era with the organization of their order, ANNO ORDINIS (A. O.) "in the year of the order."

Order of High Priesthood date from the year of the blessing of Abraham by the High Priest Melchizedek, ANNO BONNEFACIO (A. B.) "in the year of the blessing."

RULES FOR MASONIC DATES

Ancient Craft Masons—

Add 4000 years to the common era. Thus: 1976 and 4000—5976.

Scottish Rite—

Add 3760 years to the common era. Thus: 1976 and 3760—5736.
After September add another year.

Royal Arch—

Add 530 years to the vulgar year. Thus: 1976 and 530—2506.

Royal and Select Masters—

Add 1000 years to the common era. Thus: 1976 and 1000—2976.

Knights Templar—

From the Christian era take 1118. Thus: 1118 from 1976—858.

Order of High Priesthood—

To the Christian era add 1913, the year of Blessing: Thus: 1976 add 1913—3889.

REPORT OF COMMITTEE ON MASONIC RELATIONS

(Which was adopted)

To the Most Excellent Grand Chapter, Royal Arch Masons of Florida:

The Grand York Rite Bodies of Freemasonry assembled in Annual Grand Communication in Orlando, Florida on May 21, 1975 adopted the following titled Resolution, "RESOLUTION ON MASONIC UNITY" which was presented by the Grand Chapter Royal Arch Masons of Florida. The Grand Council of Florida, signed by M.E. Richard I. Lanier, Grand High Priest; M.I. Hugh R. Dixon, Grand Master, and R.E. Albert G. Rodgers, Grand Commander, resolved that these Bodies being anxious and desirous of helping further the spirit of unity, strengthening and cementing this ancient unity and pledge their support and cooperation with and to The Masonic Association of Allied and Appendent Orders in promoting harmony and unity in all branches of Freemasonry in this Grand Jurisdiction.

The adoption and implementation of the purposes of this resolution should have been a strong motivating force not only for this committee but for every one throughout the State to strive to achieve this highly desirable goal of unity and harmony among our Brothers of the fraternity, achieving a broader field of enlightenment of Truth, in the attainment of useful knowledge and the application of service to all humanity.

The York Rite Light publication has carried the itinerary of the Grand Master William C. Hill as well as other activities of the Grand Lodge.

Lodge Trestleboards and news bulletins, York Rite Bulletins, Shrine Magazines, Scottish Rite bulletins have throughout the state carried activities notices advertising each others events. This Chairman receives copies of these publications from all over the state. The Shrine Magazines have carried large space advertising upcoming York Rite Festivals and Scottish Rite Re-Unions.

Presiding Officers of the York Rite as well as Scottish Rite and Shrine have been accorded introduction at the District Conventions on honoring the Grand Master of Masons of Florida.

Letters of congratulations and best wishes for a successful term of office and pledges of our support have been mailed to Sister Mamie Horton, Worthy Grand Matron; Brother Aubrey Dykes, Worthy Grand Patron, and the other elective Grand Officers of the Order of the Eastern Star; to Most Worshipful Richard F. Griffee, Grand Master of Masons of Florida, and personal congratulations have been extended to Sovereigns of the Order of Red Cross of Constantine and the Priors of Knights York Cross of Honour and John B. Phelps York Rite College.

September 14, the Masonic Home at St. Petersburg hosted the Officers and Members of the York Rite Bodies of Florida which is an annual event specifically designated to honor York Rite and for the York Rite to become better acquainted with the facilities provided for the care of our less fortunate brothers and sisters.

The Chairman of this Committee serving as a Grand Lodge Officer and being active in various Allied and Appendent Orders, as well as many of you by traveling ritualistic and speakers, have added a great amount of mutual accord participating in the conferral of the work, performing ritualistic work in the Orders and Degrees of York Rite as well as in the Scottish Rite and further cementing our unity by being ritualistic in the ceremonies of the Shrine. We have installed officers and lodges and York Rite Bodies. Delivered in lodges as participants in conferrals and investitures to master masons. Served as participants in conferrals and investitures in the York Rite College, Red Cross of Constantine and the Knights York Cross of Honour. We have delivered patriotic address particularly on the Bi-Centennial theme. We have presented copies of the Declaration of Independence and Flags which have flown our

nations Capitol, to schools and civic groups. This Chairman addressed the Fourth District York Rite Association in Winter Haven in June 1975 and again in Dade City March 1976. Addressed the Homecoming honoring our Grand Commander Albert G. Rodgers in Sarasota on Saturday evening, Feb. 8, 1976.

We do not have a full report of all the showings of the film "Saga of the Holy Royal Arch," however, information taken from the York Rite Light reports that Companion Joe W. Aspley, D.D.G.H.P. of the Fifth District has shown this most enlightening film in lodges, temples throughout a large section of our state. For example, during the month of August he traveled hundreds of miles and showed this film in ten places to more than five hundred masons. Most Illustrious Alfred R. Peebles was donated \$700.00 worth of projection equipment and has been very busy in showing this fine film in and around the West Palm Beach area with excellent reception and results in receiving petitions for the York Rite. Ex. Companion Eugene Berata has also been very active with showing the "Saga of the Royal Arch" as well as "In The Hearts of Men," in Lake and Pasco County area, to lodges, Masonic Associations, York Rite Clubs and the National Camping Travelers Club.

The York Rite was again in the forefront in participating in the Masons for America Day held in Melbourne, Florida on September 20, 1975. This annual patriotic day in a festival of pageantry and parade is one of the finest endeavors of Masonic Relations in Action. This past September more than 4000 participants, members of all the various orders, temples, lodges, DeMolay, Rainbow, Jobs Daughters, Shrine and other Allied or masonic sponsored groups came together in a unity of brotherhood and Masonic Americanism, demonstrating fraternal fellowship and proclaiming a rededication of love and loyalty to God and Country. The principal program of this event was a stirring patriotic drama entitled "Voices of Liberty" presented by members of Ashlar Lodge No. 98, St. Augustine, Florida, the oldest City in the United States. This drama consisted of several scenes depicting the inquiry of the average citizen into several important and historical events of history which we are now celebrating in our Bi-Centennial year. No. 1—"The Minuteman" who fired the shot heard round the world. No. 2—"The Declaration of Independence" and those who composed and signed it. No. 3—"The Liberty Bell." No. 4—"The American Flag" relating places and experiences in detail from the time of Betsy Ross until the present day. This cast of "Voices of Liberty" have presented this patriotic drama throughout the states in lodges, Scottish Rite and York Rite Temples, Shrine, Eastern Star Chapters, schools, political caucuses, assembly of State Officials, and Civic groups, in groups as small as 50 and some as large as 5000. If you are interested in "booking" this drama, please hurry to contact them through the Secretary of Ashlar Lodge No. 98 St. Augustine, as their calendar is heavily scheduled already. Please note that the Masons for America Day will be held this year on July 3, Sarasota, Florida. Brother Joe Gould, General Chairman.

Conferral of the Royal Arch Widows Degree for our ladies by Ex. Companion Wilbur W. Masters and a superb cast in various places in the state, and others are scheduled at this writing, create a special entertainment for our ladies, loving fun for the husbands and support of our ladies for the time and efforts that their menfolk are doing in furthering the great humanitarian and spiritual work of Freemasonry.

Our Masonic Relations extend to other Grand Jurisdictions. Upon the assistance and direction of M.E. Walter Winchester, P.G.H.P., the Cherokee Rose Priory K.Y.C.H. No. 56, a cast of 35 members, from Atlanta, Georgia, on March 20, 1976, with the Clearwater Council No. 34 R.&S.M. as host joined by Polk Council of Winter Haven, as a special centennial event, presented in Clearwater Masonic Temple, their very special degrees of the Council including the Super Excellence Degree.

In November, 1975, the Tampa York Bodies named the Fall Festival as the "William Clifford Hill Class" in honor of the Grand Master of Masons of Florida.

Although there has been some conflict of schedules of events, some could have been avoided had there been proper reciprocal planning among those

presiding officers who have the authority, while others could not have been avoided as time and place would not permit otherwise, this Committee is pleased with the total effort and results of the purpose for which was created and within the scope of its authority.

The Chairman is pleased that the purpose enumerated in the Resolution for Masonic Unity as presented at the first of this report have been completed with hope to the satisfaction of the Grand High Priest, the Grand Master of the Council and the Grand Commander.

WHEREAS approximately fifty years ago, Illustrious Melvin M. Johnson, Past Grand Master of Masons in Massachusetts, issued the following statement, when he wrote in "The Beginnings of Freemasonry in America":

"A study of the tremendous influence which Freemasonry had in the Pre-Revolutionary days, in the years of that war, and through the formative period of American institutions, will demonstrate that Freemasonry has exercised a greater influence upon the establishment and development of this Government than any other single institution"; and

WHEREAS, in the light of the truth of that statement, it seems to be particularly appropriate that Masons should, during this bi-centennial year of our Nation, re-evaluate the contributions made by those patriot Masons, and it is even more appropriate that we should, at this time, re-dedicate ourselves to those fundamental Masonic concepts which are so essential to the preservation of our American way of life; and

WHEREAS this great Nation is now celebrating the two hundredth anniversary of the institutionalization of those fundamental ideals which we know as The American Way of Life; and

WHEREAS the fundamental philosophy of Freemasonry closely approximates those concepts of American Democracy; and

WHEREAS eminent Freemasons participated so effectively to the establishment and development of those ideals in the United States; and

WHEREAS some of the conditions which exist in modern society are demonstrating so conclusively the need for an active implementation of those ideals;

NOW, THEREFORE, BE IT RESOLVED that: we as Free Masons in Annual Convocation, this 19th day of May, 1976, do promise and vow to renew the sacred obligations which we voluntarily assumed before Almighty God, at His Sacred Altar and upon His Holy Word, pledging a steady obedience to the tenets of our institution, inculcating the practice of those truly commendable virtues of Sincere Affection, Brotherly Love and Truth; reaffirm our Faith in

our Great Creator and the Great Light of Freemasonry which He has given us as the Rule and Guide to His faith and practice; rededicate ourselves to the fundamental principles of our Fraternity and the American Way of Life, that it may also be said of us by our posterity that we as Masons and good citizens through our thoughts, words, and actions, gave the very best of our honor and integrity to protect and preserve our glorious heritage as planned by our founding fathers: among which are life, liberty and the pursuit of happiness; providing for the separation of Church and State; ensuring religious freedom that each may enjoy according to his own belief; providing a system of Justice which all ensure Equality under the Law for every man without distinction; providing Educational opportunity for the enlightenment of all its citizenry, that the Light of Truth may dispel the darkness of superstition and error; providing for the protection of the dignity of the individual, his person, his family and his home; and providing a system of government of the people, by the people and for the people, and that it should not perish from this earth.

AND, BE IT FURTHER RESOLVED, THAT: since Almighty God in His infinite wisdom has seen fit to design that this 200th anniversary of the formation of our Nation shall occur on the Sabbath Day, July 4, 1976, that this day be observed also as a day of Thanksgiving and Devotion to Him from whom all blessings flow, calling upon all Masons wherever dispersed to pause and reflect upon these truths, His immutable gift of love and grace, and in an attitude of humility, thanks and worship, to attend the Church, Synagogue or Temple of his choice, praying for His continuing guidance upon our Nation, that love and peace among all men shall prevail throughout the world, and that He may continue to bless our Native Land, the land of the Free and the home of the Brave; and praying further:

ADDRESS BY GENERAL GRAND HIGH PRIEST GORDON R. MERRICK
of the General Grand Chapter R.A.M. International

M.E. Grand High Priest and my Companions, it was not on my itinerary to be here this year as I had planned to be with you next year, but last week we learned of the need of surgery on Companion Robrt F. Secrest, the General Grand Principal Sojourner, who was to be present at this meeting.

We in General Grand Chapter this year are attempting to improve communications. We feel that with the resurge that is taking place in the various Bodies of Masonry, we should try to improve communications. International York Rite Council nine years ago sought to achieve co-operation among all the different bodies to a greater extent than ever before and I am glad to report that we now feel that we are getting fine-co-operation from all the Bodies.

In Las Vegas we had a workshop open to all members and this will be resumed in Denver in 1978. Two things came out of that meeting which we deem of great importance. One was the film "Saga of Royal Arch Masonry" and the adoption of a Philanthropy which we felt were needed in addition to degree work and fellowship, and thus developed the Royal Arch Research Assistance, R.A.R.A. All moneys for this project are on a voluntary basis, we have no assessments.

The Committee on Work is pleased to report that many schools of instruction were held in various districts and chapters and were all well attended, and we were pleased that the companions present were so interested in improving their work.

After many conversations between the members of this Committee, and a week-end sessions, we were enabled to compile sufficient information so that sufficient progress has been made in accord of the report of this Committee as adopted in 1975.
