J. The Grand High Priest is authorized to appoint one District Instructor for each District, which District Instructors shall not exceed the District Deputies in number, for a term of one year, to work in their respective Districts under the supervision of the Grand Chapter Committee on Work, subject to the approval of the Grand High Priest.

1. Each District Instructor shall be found proficient in all ritual by the Grand High Priest, the Grand Chapter Committee on Work and be holder of a white card.

2. The title of District Instructor shall be "District Instructor" and the title of a Past District Instructor shall be "Past District Instructor" for life. District Instructor may be abbreviated "D.I." and Past District Instructor may be abbreviated "P.D.I." 24

3. Each District Instructor shall hold two Schools of Instruction in each Chapter in his District and send a report to the Committee on Work.
