(1) See that all Constituent Commanderies of this Grand Commandery are uniform in the use and interpretation of the Ritual and Asylum Tactics. **The Grand Commander may, at his discretion, designate qualified and experienced Sir Knights as District Instructors - one for each of the Grand Commandery districts, who will support Constituent Commanderies in learning and exemplifying the work.**
