LANGUAGE TO BE AMENDED (deleted, changed, etc.)

- a) Appointed Grand Commandery Officers shall be entitled to wear an officer cordon, chapeau rosette, sleeve patches, and belt buckle as authorized for an Officer of this Grand Commandery, together with the appropriate shoulder strap of their office, during their incumbency as an appointed Grand Commandery Officer or until their successor is appointed and installed; thereafter, they shall return these items to the Office of the Grand Recorder.
- c) Past Grand Commandery Officers (except Past Grand Commander) shall be entitled to wear a cordon as described in these Regulations.


- a) Appointed Grand Commandery Officers shall be entitled to wear an ~~officer cordon~~ **approved jewel of office**, chapeau rosette, sleeve patches, and belt buckle as authorized for an Officer of this Grand Commandery, together with the appropriate shoulder strap of their office, during their incumbency as an appointed Grand Commandery Officer or until their successor is appointed and installed; thereafter, they shall return these items to the Office of the Grand Recorder.

DELETE entire subparagraph (c)

- e) ~~Past Grand Commandery Officers (except Past Grand Commander) shall be entitled to wear a cordon as described in these Regulations.~~
