

Allen was born in Connecticut, however his parents moved back to Scotland when he was four. He came back for the military to serve in the US Navy when he was seventeen and went back to the UK after that. Came back over for a third time, this time to Sarasota, Florida in 1999 and has been here since. He works for a Tax Software company as a Director of Information Security.

Brother Sorbie was duly entered an Apprentice, passed to Fellow Craft and raised to the sublime degree of Master Mason in The Caledonian Lodge of Uganda No. 1389 of the Grand Lodge of Scotland, on the 23rd day of July 1994. In October of 2005 he became a plural member of The Builders Lodge No. 376 Free and Accepted Masons, ultimately becoming Worshipful Master in 2008. In 2014-15 he was installed as District Deputy Grand Master for the 27th Masonic District.

He went on to become Companion Sorbie having been duly admitted to the Degrees of Mark and Excellent Master, Exalted to and instructed in The Mysteries of the Royal Arch Degree of Free Masonry at the Laird O' Cockpen Royal Arch Chapter No. 500 upon the 28th Day of March 1995. Nine years later he became a Knight Templar and enrolled as a life member of the Preceptory in the Lothians, on the Roll of the Great Priory of Scotland on February 24th, 2004.

He went through the Cryptic Council in 2009, and then became a plural member in Manatee River RAC & Trinity Commandery thus completing the York Rite circle. For Chapter, since 2010, moved through the line serving as Excellent High Priest in 2014 and was appointed District Deputy Grand High Priest in 2015. For Council, stepped into the chair of Steward in 2011 and moved through the line serving as Illustrious Master in 2015. He was appointed Grand Sentinel for the Grand Council of Royal & Select Masons of Florida in 2015. For Commandery he stepped in as Prelate in 2010, installed as Eminent Commander in 2018 and served as District Deputy Grand Commander in 2019.

He was made a Master of the Royal Secret of the 32 Degree of the Ancient and Accepted Scottish Rite Valley of Tampa Scottish Rite in 2006 and installed in Consistory as the Master of Kadosh in 2019. He was also President of the Past Masters Unit Sahib Shrine in 2013, Sovereign Master of the Allied Masonic Degrees in 2017, Excellent Chief of the Knight Masons in 2019 and serves as an officer in the Pentagon York Rite College, Red Cross of Constantine and KYCH.

Minutes of the 142nd Annual Assembly of the Grand Council of Royal & Select Masters of Florida Held on May 18, 2022

Bradentown Council No. 9 opened in full form and the Grand Council Officers were then received and introduced. Most Illustrious Grand Master Wm. Allen Sorbie was given Grand Honors and escorted to the East. He was handed the gavel, instructed his Officers to take their stations, and declared Bradentown Council closed and opened the 142nd Grand Assembly opened for business.

MEGHP James F. Robertson and REGC Adam M. Bryan were brought in, given Public Grand Honors, and escorted to the East.

The Past Most Illustrious Grand Masters of Florida were brought in, introduced and given Grand Honors.

Visiting Dignitaries from other jurisdictions were brought in and introduced.

General Grand Council representative, Right Puissant Thomas Nesbit, was introduced and brought up to the East.

A roll call of Grand Council Officers, District Deputies, and Grand Representatives was done by the Grand Recorder.

The preliminary report of Returns & Credentials was read and the Grand Recorder certified that there was a quorum present.

The Grand Recorder made a motion that the minutes of the 141st Annual Assembly be accepted as printed. Motion Passed A motion was made to accept the pre-printed reports as distributed, minus the Proposed Budget and the MIGM final report. Motion passed.

MIGM Allen Sorbie thanked the craft for all of their support and patience. He then put the Grand Assembly at ease until 1:00 PM for the Installation of Officers.

Grand Master's Report

Report of the Most Illustrious Grand Master 2021-2022 Looking back on my year, I am so proud of what we have accomplished. All the hard work that's been put towards raising money for our flagship charity the CMMRF has been phenomenal with nearly all Districts having sold their allotment of baseball caps, shirts and ties and even taking on more.

The teamwork I have seen putting together our Festivals is paying off huge dividends with new candidates being in the double digits all over the state. The uptick in visits to Blue Lodges and putting on the Circumambulation and the Peculiar Stone presentations has been incredible and I'm sure will go a long way to help promote our York Rite numbers for sure! Putting to good use the First Responders Award provided by the Cryptic Masons International to promote our Councils is another great tool and let us not forget all those Zanzabar Degrees with all monies raised directly donated to the CMMRF. Both great ideas being brought to the table and making a significant impact to our collective efforts. Every time we get together and I hear of all these great things I truly feel humbled and proud to call you all my Companions.

State of the Crypt

Our District Meeting format was the same as the previous year in the sense of a "Virtual District Meeting" and the only attendees were Cryptic Masons. My decision was based on having to make this call at the beginning of the year and there was still a high level of uncertainty around the pandemic at that time. Five were scheduled throughout the year, two District participating in each.

We kept with the same open format where we met around 9am on a Saturday. By open format, I mean casual dress, no purple coats, and ties; just something comfortable. These meetings lasted no more than 1 ½ hours so the Companions could get back to spending time with their families on a weekend.

The format of the meeting was with a few formalities then quickly on to an open discussion. The intent was for us to hear what the Companions have to say about what's happening in their Masonic world, not be bored to tears by their Grand Line. We hosted two Districts at a time, and the DDGMs handled the facilitation of the meeting.

My observation was that although this was a necessity and a new style of communicating when still in the midst of a pandemic, it was still too big a change for our Companions. The attendance was much lower than the previous year and the meeting had several technical issues both with hosting and attendees. I do not recommend this as an alternative in the future and earnestly recommend that in-person meetings are kept and promoted.

On the other hand, our monthly Grand Line Officers Virtual Meeting seemed to be very successful. This was well attended, and the sharing of information was phenomenal. We spoke about upcoming festivals, fundraisers like the Zanzabar Degree, installations, official visits, CMMRF Updates – not only the money raised but also the number of Ties and baseball caps were sold. This provided a great opportunity for everyone to compare notes and benefit from each other's successes.

There were no Councils this year that requested to compete in the Keith W. Dean ritual competition award program. I sincerely hope that we can resume and increase the number of Councils that wish to improve their ritual skills in the future. Competing in programs like this rewards the Council's cohesiveness and fellowship with the knowledge that you are the best we have to offer whether you win or not.

We are fortunate to have Companions who are dedicated in making Florida one of the top contributors in the Nation. This past year our total contributions to the Cryptic Masons Medical Research Foundation was \$43,330.93 – Thank You Companions!

I personally would like to thank R.:I.: Tom Olsen for all the hard work he put in by helping me coordinate the acquisition and selling of ties and baseball caps around the State though each of our appointed District Deputies. He also kept track of the monies and many other donations made for the CMMRF. I also must give a big thank you to MIPGM Dayle L. Schrock, the assigned CMMRF District Representatives, every Council and each member that helped make this year such a success. Florida has been number one in donations ten times out of the last eleven years. Let us hope that you can continue to support CMMRF in the future as you have done in the past. Many events were cancelled this year due to COVID-19 including Council meetings, Festivals, Installations, as well as many allied and appendant body programs. When we are again confident and able to meet let us make up for lost time and continue our commitments to York Rite and all of Masonry in search of that fellowship that we have been deprived of.

Official Visitations and Masonic Activities

I was able to attend the Grand Master's Banquet in May. The meal was nice, no assigned seating. I sat at the Masonic Home table and had a great chat with Lisa Tsotsos. The Grand Master's Dinner at Maghianno's two days later was very interesting. I sat with the Alabama Grand Line Officers and had a great time and learned a lot about beekeeping. The Southeastern Conference was one that I truly did enjoy the experience, meeting all our fellow Grand Line officers from other States and sharing ideas. The banquet was tasty, they served a decent pork with a great chocolate dessert. We had the editor for the Knights Templar publication on our table, that was a very interesting conversation for sure. Florida's was presented a very nice silver tray/placard in recognition for their exemplary CMMRF fundraising efforts, this was indeed an honor to receive on behalf of our team. The International Order of the Rainbow for Girls 75th Grand Assembly was a great meal. The meeting was full of energy and very well coordinated. The DeMolay's 88th Annual State Conclave -Dinner had a wonderful compliment of spokespersons. The Super Excellent Degree in Bartow was a great success in almost every way. The general attendance was very good, and we had somewhere around 60+ candidates. We served 73 meals and sold 69 Yamakas. After expenses we had a net profit to go to CMMRF of \$605.45. Grand Treasurer Report

The Most Illustrious Grand Master operated within his budget during his term and should be commended for good management of his resources. Again, this year, it was not necessary to use any of the Administrative Fund earnings, so those assets remained invested. Unfortunately, the downturn in the market did impact the overall financial status of the Grand Council, but since we didn't draw from the Administrative Fund, the impact has been deferred. Looking at the Grand Council accounts from a cashflow perspective, we spent \$4,245.13 less than we received. The MIGM opted not to take his allowance which amounted to \$3,000.00 of that underspending. As noted last year, the per capita income received during this term is reflected in cashflow but doesn't give a true picture of income since it is carried forward as income for the 2022-2023 budget.

I have attached the May 31, 2022, Balance Sheet; the 1 June 2021-31 May 2022 Income Expense Summary Report; and the 2021-2022 Approved Budget versus Actual Report.

I wish to thank the Grand Council Assembly delegates for reelecting me as Grand Treasurer. I will continue to serve and am honored by the confidence the Companions have entrusted in me to manage the finances of this organization.

The Grand Office had a favorable year financially. The Office Manager position was vacant for most of the year and our Grand Secretary/Recorder covered this vacancy by doing the work himself or using temporary help, mostly during the preparation for the Grand Convention. The Grand Chapter contributed \$17,915, the Grand Council contributed \$17615, and the Grand Commandery contributed \$16710 toward the office operating expenses. At the end of the year, the unspent funds were returned in proportion to the contributions: Grand Chapter - \$4,640.30, Grand Council - \$4,562.60, and Grand Commandery - \$4,328.19. The Grand Secretary/Recorder

should be commended for running the office efficiently and thus coming in under budget.

During this term, the Life Perpetual account received \$17,825 in new membership contributions and an additional \$120 in Knight Templar Eye Foundation memberships. An additional \$26,000 was withdrawn from the Life Perpetual Investment account to cover the payout expenses. The KTEF funds simply passed through the account and were forwarded to the Grand Encampment. This year's payouts were: Grand Chapter -\$14075.85; Grand Council - \$12, 617.72; and Grand Commandery - \$15,206.16. I anticipate needing to make a similar withdrawal from the investment accounts to fund the 2023 payouts.

Grand Recorder Report

This report is NOT the direct words of our elected and installed Grand Secretary/Recorder Richard Brooks. Richard, as most of you know, passed this life on July 31st of 2022 and before he had penned his report for the year that ended on May 31st of that same year. Thus, this report is largely the work of his replacement Grand Secretary/Recorder, Carl Gilmore and is intended to as accurately as possible summarize Richard's work.

The GYR office produced the Proceedings of 2021 within the proscribed time frame and was properly distributed soon after the 1st of October 2021.

Similarly, Chapter and Council dues cards were produced and sent to local Secretary/Recorders soon after the Proceedings were sent.

We continue to update the website with pertinent information and forms. I would like to thank ME Arthur Ahrens for all his exceptional work in maintaining flgyr.org. His dedication has allowed us to make the website easier to navigate.

We are fortunate to have Companions who are dedicated in making Florida one of the top contributors in the Nation. Thank you Companions for your donations totaling \$43,330.93

I would like to share a little about their research:

- 1. Dr. Murphy and his team of researchers had a major breakthrough in their ARREST Trial studying Abdominal Aortic Aneurysms.
- The ICVBM, Indiana University School of Medicine 2. and Indiana Center for Vascular Biology and Medicine and Vascugen, which is an iPSC, induced pluripotent stem cell therapy company advancing its novel vasculogenic cell technology to develop and manufacture engineered vascular cells. The biotech company that Dr. Yoder has founded, have had discussions with the US Food and Drug Administration regarding a clinical trial in patients with CLI critical limb ischemia, using their iPSC, now called VSC-100.
- 3. Vascugen has met with a large investor regarding a clinical study and in February the ICVBM clinical team will join Vascugen to discuss the potential of a clinical trial using VSC-100. If this company funds a clinical trial it will fast track the use of this cell by years and could be a major breakthrough in prevent amputations in patient with CLI, especially diabetics.

Following the approval of this report, it will be our pleasure to acknowledge our well desired Companions & Councils with their Gold Pins with Diamonds, Plaques and Extender Bars.

Investment Committee

The investments under the oversight of this Investment Committee are maintained by our investment advisers at Edward Jones & Co., and presently total \$719,975 as of 31 March 2022, up from \$702,670 a year ago. This represents a 2.46% NET increase in Grand Council invested assets, even after the required 5.00% payout on Perpetual membership funds, and even <u>after</u> the losses incurred in February and March of 2022. These dollars are broken up into two major portfolios:

<u>Administrative Account</u> - The first portfolio is the Administrative Account, also sometimes referred to as the General Fund. As of 31 March 2022, the total value was 335,804 - vs. 317,257 as of one year ago, for an increase of 18,547, even after the decline in values experienced during the months of February and March of this year. This account has a target investment mix of 60% equities, and 40% bonds and other fixed instruments.

At 31 December 2021, the total value of this account was \$352,458, vs. \$305,319, at 31 December 2020, for an increase of \$47,139, or an 15.44% investment return. It is significant to note that our governing documents allow 75% of this annual increase to be included in the Budget for the following year, which could currently increase our available funds for charitable and necessary operating expenditures by \$35,354.

The original primary goal of the Administrative Account was to put the Grand Council in a position to be able to place less reliance upon Per Capita dues increases in the future, as this Fund grew. Instead of using these funds as originally intended, the funds have been allowed to accumulate, while significant Per Capita increases have been recommended and approved in recent years. During this past year, a total of \$Zero was paid out of this Fund account.

<u>Life and Perpetual Account</u> – The second portfolio is the Life and Perpetual Account, often referred to as the Sacred Fund. As of 31 March 2022, the total value was 384,171 - vs.

\$385,414 a year ago, for a decrease of (\$1,243), after the decline in values experienced during the months of February and March of this year, and after the payout of the 5.0% annual perpetual payments to constituent Councils. This account

has a target investment mix of 50% equities and 50% bonds and other fixed instruments. As interest rates rise, the underlying value of a fixed-rate bond portfolio generally goes down.

At 31 December 2021, the total value of this account was \$402,911, vs. \$378,793 at 31 December 2020, for an increase of \$24,118, or a 6.37% NET investment return, after the required 5% perpetual fund payout.

I would like to take this opportunity on behalf of myself and the other members of the Investment Committee to thank the Most Illustrious Wm. Allen Sorbie, MIGM, for allowing us to serve the Grand Council this past year.

The Grand Council Jurisprudence Committee met on Saturday, May 14th, to review the actions pertaining to the rulings and dispensations acted upon by the Most Illustrious Grand Master, William Allen Sobie during his 2021-2022 Cryptic year.

The full Committee closely examined the actions taken by our Grand Master and determined that all his actions were within purview of his office.

Eight requests for dispensations, and eight requests for bylaw amendments, and one Executive Order were reviewed. In regarding the By-Law amendment of Council No. 15 of St. Augustine dated December 21st of 2021 the phrase "meet in conjunction" is confusing and should be changed to "meet following" in a new By-Law Amendment. All dispensation, other bylaw amendments, and executive order were within his authority.

The Committee determined that all actions taken by the Grand Master were acted upon in a timely manner, each properly received and bearing official stamps of the Grand Recorder and Grand Master.

Although the Grand Master's report was not properly received by the Committee thirty days prior to the Jurisprudence meeting, the Committee understands.

The Committee would like to commend Grand Master Sorbie for having the stamina to complete his term and having faithfully discharged the office of Most Illustrious Grand Master during his Cryptic year. We thank him for the honor and privilege he has provided us to serve the Grand Council.


